**COMMISSION STAFF’S REQUEST FOR CORRECTION TO THE
NOTICE OF APPROVAL**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff) representing the public interest, and files this Request for Correction to the Notice of Approval. In support thereof, Staff shows the following:

I. BACKGROUND

On November 28, 2017, Goldenrod Estate Homeowners Association Inc. (GEHA) and Goldenrod Water Supply Corporation (GWSC) (collectively, Applicants) filed with the Commission an application for the sale, transfer, or merger of facilities and certificate rights in Fort Bend County. Specifically, GEHA sought approval to transfer all of its water well assets and service area under certificate of convenience and necessity (CCN) No. 12933 to GWSC. The requested area includes approximately 74 acres and 22 current customers. There were no intervenors and no hearing was requested. The application qualified for informal disposition.

On June 6, 2018, the Notice of Approval in this docket was issued. Staff requests a correction to a Finding of Fact included in the Notice of Approval.

II. CORRECTION TO THE NOTICE OF APPROVAL

Pursuant to 16 Tex. Admin. Code § 22.35(c)(1), the parties may file a suggested correction to a notice of approval within fifteen (15) days of issuance of such notice. Staff respectfully requests a correction to the Notice of Approval filed on June 6, 2018. Since this correction request is within fifteen day of the issuance of the Notice of Approval, the request is timely filed.

Staff requests a correction to Finding of Fact No. 1 in the Notice of Approval. The Finding of Fact states that the Applicants filed the application to transfer the water well assets and service area under water CCN No. 12933 on May 1, 2017. The application was filed on November 28, 2017. In order to conform to the Applicant's actual filing date, Staff respectfully requests Finding of Fact No. 1 be revised to state, "On ~~May 1, 2017~~ November 28, 2017, GEHA and GWSC filed an application for GEHA to transfer all of its water well assets and service area under water CCN No. 12933 to GWSC in Fort Bend County."

III. CONCLUSION

For the reasons stated above, Staff respectfully requests that the above listed correction be inserted into the Notice of Approval.
