COMMISSION STAFF'S REQUEST FOR EXTENSION TO FILE SUPPLEMENTAL FINAL RECOMMENDATION AND JOINT PROPOSED ORDER

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and in response to Order No. 13, requests an extension to file the supplemental final recommendation and joint proposed order. In support thereof, Staff shows the following:

I. BACKGROUND

On December 12, 2017, Countryside Acres Homeowners Association, Inc. (Countryside) filed a petition for a Certificate of Convenience and Necessity (CCN), in Midland County.

On August 1, 2019, Order No. 13 was issued, requiring Countryside to file additional information and establishing a deadline of August 22, 2019 for Staff to supplemental final recommendation and joint proposed order. Therefore, this pleading is timely filed.

II. STAFF'S REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. As of this date, the additional information required of Countryside has not yet been made available on the Public Utility Commission of Texas Interchange. Thus, Staff respectfully requests that the deadline for Staff's supplemental final recommendation and joint proposed order be extended to October 24, 2019, in order to allow for time to review the documents and incorporate the additional information into the pleadings.

III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request.
