## COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY AND PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Recommendation on Sufficiency and Proposed Procedural Schedule. In support thereof, Staff shows the following:

### I. BACKGROUND

On December 13, 2017, Knee Deep Water Company (Knee Deep WC) filed with the Public Utility Commission of Texas (Commission) an application to relinquish its exempt utility registration No. N0051 pursuant to Texas Water Code § 13.242(c) and 16 Tex. Admin. Code § 24.103(e) (TAC). Knee Deep WC stated that due to the effects of Hurricane Harvey, everything serviced by Knee Deep WC has been bought by Harris County and will not be rebuilt. The water well currently does not have electricity nor is expected to in the future.

On January 9, 2018. the Administrative Law Judge (ALJ) ordered Staff to file comments regarding the administrative completeness of the application, and propose a procedural schedule, if necessary, by January 26, 2018. This pleading is therefore timely filed.

### II. ADMINISTRATIVE COMPLETENESS AND PROPOSED NOTICE

As detailed in the attached memorandum of Debbie Reyes Tamayo in the Commission's Water Utility Regulation Division, Staff has reviewed the application filed by Knee Deep WC, and recommends that it be found administratively complete. The Commission published notice of the application in the *Texas Register* on January 9, 2018. Staff further recommends that no additional notice is required because there are no customers currently located in the area.

### III. PROCEDURAL SCHEDULE

Staff proposes the following Procedural Schedule:

On December 13, 2017, Knee Deep Water Company (Applicant or Knee Deep), filed an application to Relinquish exempt utility registration N0051 pursuant 16 Tex. Admin Code § 24.103(e) (TAC) for a utility with less than 15 potential connections. Specifically, the applicant states everything was wiped out by Hurricane Harvey.
