# SOAH ORDER NO. 2 MEMORIALIZING PREHEARING CONFERENCE, ADOPTING PROCEDURAL SCHEDULE, AND NOTICE OF HEARING

### I. PREHEARING CONFERENCE

On May 18, 2018, the initial prehearing conference was convened at the State Office of Administrative Hearings (SOAH). Randall Wilburn and Helen Gilbert appeared on behalf of Forest Glen Utility Company (Forest Glen). Oshea Spencer appeared on behalf of Staff of the Public Utility Commission of Texas (Commission). Intervenors Van Johnson and Fleming D. Mitchell appeared on behalf of themselves. Cecil Perkins and Dennis M. Brown also appeared and requested to be granted status as intervenors. The motions were granted.

### II. PROCEDURAL SCHEDULE
