DEFINITIONS

Provide documentation and a breakdown of the annual amount received for wastewater and reuse.
- Staff 4-2 As of June 1, 2018, how many Forest Glen Utility wastewater connections are actually occupied homes.
- Staff 4-3 Indicate how much of Forest Glen Utility's wastewater plant cost should be attributed to reuse processing. Please provide the calculation and factors used to determine this amount.
- Staff 4-4 Please indicate the total amount of wastewater and reuse connections respectively Forest Glen Utility will provide billable service too based on full build out.
