



DEFINITIONS

- Staff 5-2 Please reconcile the "Buildings and other depreciable assets", on line 10a, page 5 of the 2016 tax return of \$2,611,566 to the original cost of assets reflected in the rate/tariff change application, page 33, of \$2,026,113.
- Staff 5-3 Provide the calculation for accumulated deferred federal income tax as of 12/31/2016 and any proposed adjustments to the amount to be used to reduce rate base.
