INTRODUCTION

My name is Van Johnson and my spouse's name is Evette Johnson. We married in March 1980 and have two children and two grandchildren.

I served in the United States Air Force from September 11, 1979 to September 30, 2005. Two after military retirement, I gained employment with the Department of Veterans Administration until retirement in June 2016.

We moved into Potranco Ranch Subdivision December 22, 2013 after closing on the property of 112 Sunrise Hill, Castroville, TX 78009. My wife and I were encouraged with the savings we would have on using reuse water to water lawn, estimated at half of what we paid SAWS for 17 years (\$70 running sprinkler and house). See Exhibit 1, Potranco Ranch Meter and Water Rates Sheet.

After closing on the property, which the builder finished one week prior to move-in and without a sprinkler system, we needed a sprinkler system in lieu of hand-watering. Evette and I purchased our sprinkler system for installation in January 2014. Initially on move-in, we manually watered the installed, dead lawn (brown).

PURPOSE OF TESTIMONY

I am providing testimony to Public Utility Commission why I object to Forest Glen Utility increasing an already fixed sewer rate to buttress their perceived losses in operating Waste Water Treatment Plant.

GENERAL BACKGROUND

Using reuse water to water 112 Sunrise Hill, Castroville, Texas 78009 is outrageously expensive and nothing as purported by the McMillin Homes Sales Representative, that of, being inexpensive.

What makes reuse water expensive is the leached fees, e.g., sewer, EAA, AMR, TCEQ, TCEQ. Sewer rates were variable based on usage from January 2014 through December 2015. The maximum was \$29.93 initially and \$14.76 for December 2015. Suddenly, the implemented \$35 TCEQ rate established in 2012. When TCEQ set the initial rate of \$35, Potranco Ranch developer was in the stage of hollowing out the forest to build homes. My residence was the sixth house built and move-in between May and December of 2013. See Exhibit 8 for clarification.

The \$35 fixed sewer rate implementation was a bearable financial stretch, while I was employed through June 24, 2017. With the loss of income at retirement, every penny needed to be spent wisely and increased spending justified. Which brings my family to the concern of Forest Glen Utility increasing the fixed sewer rate of \$35 another \$30 because the business model isn't making enough money for financial solvency.

Based on a meeting at Sammy's Restaurant in Castroville between Mr. Steven Greenberg (CEO Forest Glen Utility (FGU)), Mr. Cecil Perkins, and me, Mr. Greenberg set out to open dialogue and in the process, he gave us a handout to follow along. To our (intervenors) surprise, the build out of Potranco Ranch Subdivision isn't expected until year 2021, not 2018 or first quarter of 2019.

In light of this revelation, the \$2,950 received by FGU upon sale of new home from the builder will continue for an additional 3 years as **income**. Yet, the \$30 additional increase is necessary. Whereas, in Forest Glen Utility Company responses to Public

Utility Commission request for information, that the \$2,950 allowed them to cover operating expenses and waste water treatment facility expansion, while only receiving \$35 fixed rate sewer charge. Therefore, the revelation itself does not support FGU's argument of financial hemorrhaging with an additional increase to \$65 fixed sewer rate. To the customer (me), it appears the additional increase of \$30 is a runaway train for the Potranco Ranch community, falsely considered to have deep pockets.

What was also revealed in the meeting with Mr. Steven Greenberg on a page of the handout is the 2021 buildout of 366 homes. See Exhibit 9 for clarification.

Some residents have opted to sell their beautiful homes due to out-of-control annual tax and Public Improvement District (PID) increases, and fees associated with reuse water. I am not so lucky to throw my hands up, as those resident's homes are still on the market for sale, some more than 6 months after the "For Sale" sign was posted on their property. It's still a home buyers' market and those that want to sell will take a bath in losses. These people and the rest of the residents are stuck with FGU without an alternative to effectively rein-in their home operating expenses. I'd gamble, if new prospective home buyers ask the questions, they (residents) are forthcoming with the unbearable issues of taxes, PID, and reuse water. Thereby, further exacerbating the issue of reaching the 366 homes at buildout.

In my assessment, FGU wants to split hairs with Waste Water Treatment Plant and Reuse Water. To residents, these elements are the same because we get one water bill, from Yancey Water Corporation) which includes potable (home use) and non-potable (lawn use) water. The non-potable water is the nightmare with the outrageous fees just to have access to reuse water. Yes, reuse is about half of potable water but the process of getting it is the true

cost.

One of the fees associated with reuse is the constant \$21.10 monthly fee for the reuse meter. This cost is levied upon users whether they have their sprinkler system on or off. This fee is rolled in the reuse fee monthly. When Mr. Cecil Perkins brought this item to the attention of Mr. Greenberg, during our meeting, Mr. Greenberg said he sees no reason why this fee couldn't be removed, but will have to address the issue with concerned business partners. An example of no reuse water is from November through February of each year. Yet, we still pay \$21.10 meter fee for reuse water.

Another bone of contention is the fixed sewer rate regardless of usage. With FGU argument of fixing the rate for all customers of Potranco Ranch excludes the pink elephant in the room, that is, not all homes have the same number of occupants. Two people reside in my home but the sewer rate is fixed at \$65 regardless of amount of water used. Then the devil's argument is how does the person with 5 or more people residing in the home pay the same \$65 when their usage is obviously more, i.e., flushing, showers, etc...

To me, the business model is flawed for such a system because the cost would be less per resident if the community was much larger than Potranco Ranch and already in place before implementation of such a supposed "green system".

Finally, I am concerned with the "no choice" alternative to reuse water and the Potranco Ranch Homeowner Association deed restriction that Only reuse water can be used on lawns. This restriction ensures homeowners are held hostage to reuse water and the fees associated with the operation of the Waste Water Treatment Facility. Normally, for every household, budgets are established to pay necessary bills and to do without those that will

bust the budget. An alternative to reuse water must be provided to customers that deem Forest Glen Utility Company's costs of service intolerable. As having a sprinkler system is a painful luxury, some residents, to include myself, considered turning off their sprinkler systems and letting the lawns go dormant for a much cheaper zero scaping. It would be a no brainer to turn off reuse service to keep from being homeless and a fix to an everailing financial Waste Water Treat Facility moocher. There just aren't enough residents between today and at build out in 2021 to curtail rising sewer rates or after build out of Potranco Ranch. Thus, the runaway train saga nightmare that has become cost prohibitive.

Several documents provided to me by McMillin Homes builder convinced me that purchasing a home in Potranco Ranch and using reuse water would be beneficial. See Exhibits 1-7.

Homeowner Letter of Introduction: Landscape Irrigation with Reuse Water

Rev 09/19/2013

The Forest Glen Utility has been approved to operate a reuse water facility that captures water from each residence and after treatment makes it available back to your home for the purpose of irrigating the landscape. If you intend to use irrigation on your landscape, the deed restrictions of your property require you to use reuse water.

Due to the standards for using reuse water for residential landscape watering, the homeowner must request approval from the Forest Glen Utility for installation of the irrigation reuse meter and system.

Please contact the Forest Glen Utility to obtain a package of information with rates and instructions for establishing your reuse water account. Water rates for the reuse water will be lower than the potable water supply – generally 20 to 40% less depending upon the amount of gallons used.

Irrigation Guidelines

Rev 09/09/2013

Design criteria used for the landscape irrigation systems shall comply with state law. If you are a licensed irrigator please refer to www.tceq.texas.gov/goto/lawn for specifics on system design with reuse water.

Vegetable gardens and green houses may not be irrigated with reuse water.

Outdoor hose bibs must be installed using the potable water source.

Per TCEQ a licensed BPAT tester must test all backflow devices on the potable water supply annually. Forest Glen Utility will be completing the testing and the Testing and Maintenance reports will be filed with the Forest Glen Utility. The cost of testing the backflow device on the home will be included in the December water re use bill.

The transfer of reclaimed water may be terminated immediately if the Forest Glen Utility becomes aware of any misuse of the reclaimed water by the user, regardless of contract provisions.

If the Builder is providing landscape and irrigation services as part of the builder's package — the establishment water budget provided must be used to irrigate the new landscape as efficiently as possible.

If the Homeowner is contracting for landscape and irrigation services themselves – the establishment water budget provided must be used to irrigate the new landscape as efficiently as possible.

After establishment of the landscape – the water budget guidelines will be used to provide the proper amount of irrigation to the landscape.

The total square footage of irrigated landscape using reuse water must not exceed 10,000 square feet. Request to exceed the 10,000 SQ FT of irrigated water purchased MUST be submitted to the Forest Glen Utility Company prior to the reuse meter installation for approval. All subsequent requests pertaining to the re use meter will need to be submitted to Forest Glen Utility for approval.

Landscape design criteria should embrace the basic principles of xeriscape and plant material selection should be appropriate for the South Texas region. Please review the principles included with this packet of information.

Save Water with Smart Landscaping and Irrigation. Please review the tips included with this packet of information. These tips are designed to improve your water savings in the landscape. Incorporate as many of these helpful tips as possible.

FOREST GLEN UTILITY COMPANY RULES AND REGULATIONS

- The Utility Company shall furnish, subject to the limitations set forth in this Customer Sewer Service Agreement, its Rules, and its Tariff, such treatment and disposal of wastewater and provision of reclaimed water for irrigation as the Customer requires in connection with the Customer's occupancy of a primary, residential structure, subject to the Utility Company's rules as well as the Drought Contingency rules of the water service provider.
- If this is a new installation, the customer is required to clearly mark the property lines with a stake and mark the side of the lot where they prefer the new connection be installed (connection will be installed along one of the side property lines within the street right-of-way). The Utility Company reserves the right to determine the final location of the connection site.
- Any delinquent payment or late charge payment by a check that is not honored will result in a penalty being assessed or a deposit being required.
- Customer is responsible for all plumbing on their side of the sewer connection.
- Customer who executes this AGREEMENT is prohibited from using the sewer system for any purpose other than as a temporary connection prior to transfer to the resident of the home. The Utility Company may terminate service or require the Customer to complete a Customer Service Agreement if the Utility Company, at its sole discretion, determines that the Customer is using the system for a residential purpose.
- Customers are forbidden to attach any ground wire to any plumbing, which may, or may not be, connected to the Utility Company's system.
- The Utility Company or its duly authorized agents shall at all reasonable times have the right to enter the customer's premises for any purpose.
- Any change in connection size or change in connection location, requested by the customer, will be charged time and materials and will be performed at the discretion of the Utility Company.
- It is the responsibility of the customer to notify the Utility Company of any change of ownership, change of use, or change of billing address. For the Customer's protection, in case of any emergency situation, please ensure that the Utility Company has phone numbers on file to reach the Customer if the Customer is absent from Medina County.
- The Utility Company, at its sole discretion, may terminate service to any Customer that the Utility Company finds in noncompliance with the Customer Service Agreement, the Utility Company's Rules and Regulations, or the Utility Company's Tariff.

- The Utility Company will mail bills monthly. The due date of bills for utility service is sixteen (16) days from the date of issuance. The postmark on the bill or, if there is no postmark on the bill, the recorded date of mailing by the Utility Company constitutes proof of the date of issuance. Payment for utility service is delinquent if the Utility Company does not receive full payment, including late fees and the regulatory assessment, by 5:00 p.m. on the due date. The Utility Company will charge a late penalty of 10.0% on bills received after the due date. After mailing a late notice, the Utility Company may disconnect if amount due and late penalty are not paid in 10 additional days. A Reconnection charge will be applied to the Customer's account for reconnection of service. Payment of all service charges and fees must be received by 5:00 pm of the regularly scheduled work day in order to have sewer service reconnected. Any reconnections performed after regular business hours, on weekends, or holidays shall be assessed an after-hour premium. The Customer understands and agrees that the Utility Company shall not be liable for the delivery of the mail through the United States Postal Service (USPS). If the Customer does not receive his or her billing statement within a reasonable period of time, the Customer is responsible for either making payment (approximate) to the Utility Company, including account number on all checks, contacting the Utility Company to obtain another copy of the Customer's billing statement, or acquiring a current account balance due to the Utility Company, at which time the Customer shall make payment in full.
- Once this AGREEMENT is executed, the Monthly Minimum will be billed monthly regardless of whether the Customer uses any utility service during the month. If this bill is not paid for any reason, the water connection will be removed and new installation fees will apply.
- The Property Owner hereby grants to the Utility Company, its successors and assigns, a perpetual easement in, over, under and upon the Property Owner's land at such point as a sewer service or reclaimed water connection is made by the Utility Company and ten (10) feet in all directions thereof for the exclusive purpose of line connection to the utility system of the Utility Company, including right of ingress and egress for the operation, inspection, repair, maintenance, replacement, and removal purposes.
- The Property Owner shall install and maintain, at his/her own expense, a service line which shall begin at the connection and extend to the dwelling or point of use. Each Customer shall have a separate and distinct service connection to the Utility Company's utility system with a connection supplied by the Utility Company at the Customer's expense. The Utility Company shall have final authority in determining the location of a service line connection to the Utility Company's utility systems.
- The service line shall typically connect with the Utility Company's sewer system at the nearest point of use by the Customer, provided the Utility Company has determined, in advance, that the system is of sufficient capacity to permit delivery of wastewater at that point.
- The Customer agrees that no other past, present, or future source of wastewater system shall be connected to any sewer lines served by the Utility Company's sewer system and the Customer shall disconnect from any present wastewater system prior to connection to and switching to the Utility Company's system and shall eliminate any present or future cross-connection in the Customer's system. The Utility Company may terminate sewer service to any Customer immediately for any noncompliance with this provision.
- If payment of the bill is delinquent an average of 3 times in a one year period, a deposit of \$50.00 will be required to keep said account active. When the account has been in a current-paid status for a one (1) year time period, this deposit amount will be refunded to the customer.
