In Order No. 2, the ALJ found the Application for Sale, Transfer, or Merger of Facilities and Certificate Rights in Denton County to be administratively incomplete and insufficient for filing, as described in the Public Utility Commission (Commission) Staff's filing including the attached memorandum of Debbie Reyes Tamayo in the Commission's Water Utilities Regulation Division. Applicant files this First Amended Application to correct the noted deficiencies.

I. PURPOSE OF APPLICATION

The purpose of this Application is to transfer the entire CCN area. This application <u>does not</u> seek to change the CCN area. The area should be =/-90 acres, and the Amended Application has been changed to reflect this.

III. APPLICATION CONTENT

1. Purchase and Sale Agreement has been added and filed as Confidential. To clarify the effective date of the sale, the sale will close within fourteen days after expiration of the 120 day review period after proper notice, because that time period will have expired by the time the Commission approves this sale, which is the event that begins the countdown to closing. The contract uses a formula to determine the actual closing date because the parties did not know at time of contracting when the Commission would approve the sale.

2. Most recent TCEQ inspection report has been added, see enclosed.

IV. FINANCIAL CONTENT

- 1. Section 13.c. of the Application has been amended; amended application enclosed.
- 2. The tariff for the system being purchased has been added, enclosed.
- 3. A statement indicating how the Buyer intends to pay for the system has been filed as Confidential since it relates to the Confidential supporting documentation.
- Supporting documentation demonstrating the Buyer's ability to pay for the system, as discussed with Fred Bednarski, have been filed as Confidential.
- 5. Regarding which entity and time period the historical and projected financial statements on pages 9-13 of the Application represent, bear in mind this is a transfer of the entire system. The 2012-2017, and 2018-to-Closing-Date financial information is for the seller, Joseph C. Desmit d/b/a Knob Hill Water System. The financial information from the date of closing in 2018-2022 is for the buyer, Knob Hill Water Utility Corp., owned 100% by Ms. Sukhdeep Kaur.

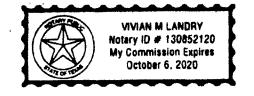

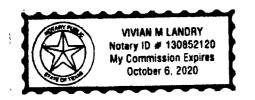

Experience and qualifications of the applicant to provide adequate utility service to the requested area Applicant has entered into a Consulting Agreement with the current individuals who operate the system, and have operated the system continuously since 1994, to run the day-to-day operation of the system. The applicant therefore will have the exact same experience and qualifications as the transferor/current owner to provide adequate utility service to the requested area. Additionally, the President of Applicant has obtained her Class D Water Operator License and will be trained by the Transferor pursuant to the Consulting Agreement to operate this particular water system in the same manner as the current owner.

- Part C.11.D. Describe the anticipated impact of this transaction on the quality of utility service and explain any anticipated changes in the quality of service. There will be no impact of this transaction on the quality of utility service. The Buyer/Transferee has entered into a consulting agreement with the Seller/current owner to manage the system for four months after Buyer purchases the system, during which time the Buyer will also train Buyer how to operate the system. The impact to the quality of service would occur if this transaction did not occur. Seller is an individual in need of retiring from active work, including managing the system on a daily basis. This transaction is practically necessary in order to continue proper operation of the system.
- Part C.11.E. How will the transaction serve the public interest?

It is in the public's interest that the Knob Hill Estates subdivision be provided with continuous and adequate water service. This system's certificated area only includes the Knob Hill Estates subdivision, an 80 lot single family residential development on the shoreline of Lewisville Lake where it is still not economical to extend another area retail public utility's lines. This system is a groundwater-based system and therefore has all the normal and ordinary costs and operational requirements of such a system. The seller is an individual who has reached retirement age and therefore needs to transfer this obligation to serve the public interest. The Buyer is technically and financially qualified to continue this system's public service to its certificated area, such that this transaction will have no effect in quality or continuity of service.

During the comprehensive compliance investigation, it was noted that the seal was not properly maintained on Well #1 and Well #2.

30 TAC 290.41(c)(3)(K) states that wellheads and pump bases shall be sealed by a gasket or sealing compound and properly vented to prevent the possibility of contaminating the well water.

Recommended Corrective Action: Seal the wellhead on Well #1 and Well #2. Submit a letter describing the action taken and a copy of supporting documentation to the ITCEQ Region 4 Office to document that the alleged violation has been resolved.

Resolution: On May 19, 2017, documentation was received from the water system at the TCEQ D/FW Region Office. Included in the documentation were photographs of the flex seal added to Well #1 and Well #2. 30 TAC 290.43(c)(3) Overflows shall be designed in strict accordance with current AWWA standards. If the overflow terminates at any point other than the ground level, it shall be located near enough and at a position accessible from a ladder or the balcony for inspection purposes. The overflow(s) shall be sized to handle the maximum possible fill rate without exceeding the capacity of the overflow(s). The discharge opening of the overflow(s) shall be above the surface of the ground and shall not be subject to submergence. The discharge opening shall be covered with a gravity-hinged and weighted cover, an elastomeric duckbill valve, or other approved device to prevent the entrance of insects and other nuisances. When the tank is not overflowing, the cover shall close automatically and fit tightly with no gap over 1/16 inch.

Recommended Corrective Action: Repair or replace the overflow on the ground storage tank at Water Plant #1. Submit a letter describing the action taken and a copy of supporting documentation to the TCEQ Region 4 Office to document that the alleged violation has been resolved.

Resolution: On June 6, 2017, documentation was received from the water system at the TCEQ
