 - e) Current accumulated depreciation account balance.
 - f) The net book value of the asset.
 - g) For subsections d, e, and f, the sum totals of all the assets in the corresponding subsection.
- STAFF 1-2 Please reconcile the sum totals from Staff 1-1(g) to the fixed asset amounts for the current year listed on the historical financial statement provided in the application on page 9 of 23.
- STAFF 1-3 Please reconcile the sum totals from Staff 1-1(g) to the fixed asset amounts provided in the rate/tariff change application filed at the Texas Commission on Environmental Quality (TCEQ), or its predecessor agency, under application number 37152-R.
- STAFF 1-4 Please reconcile the sum totals from Staff 1-1(g) to the land and improvements, system, and tangible personal property listed in the Purchase and Sale of Retail Public Utility agreement provided in item 11 of this docket, 47899 CONFID Page 103.
- STAFF 1-5 Please provide corrected responses to application page 6, question number 13.A., and application page 7, question number 13.C., taking into account the reconciled information provided in response to Staff 1-1 through 1-4.
