**MOTION TO EXTEND DEADLINES AND REVISE PROCEDURAL SCHEDULE**

**TO THE HONORABLE ADMINISTRATIVE LAW JUDGE JEFFREY J. HUNN:**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and respectfully requests an extension of the deadlines provided in Order No. 4. In support thereof, Staff would show the following:

**I. BACKGROUND**

On April 4, 2018, Order No. 4 was issued and deemed the application of Knob Hill Water System and Knob Hill Water Utility Corp. (applicants) for sale, transfer, or merger of facilities to be administratively complete. Furthermore, the order provided a procedural schedule which required applicant to file with the commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties by May 17. These affidavits and notice have not been provided. Staff therefore requests the following revised procedural schedule:

EVENT	DEADLINE
Deadline for applicants to file with the commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties	May 31, 2018
Deadline for Commission Staff to file a recommendation on sufficiency of notice and proposed additional procedural schedule	June 7, 2018
Deadline to intervene	30 days after notice is issued

## II. CONCLUSION

Staff respectfully requests the adoption of the aforementioned revised procedural schedule.


