TO THE HONORABLE ADMINISTRATIVE LAW JUDGE JEFFREY J. HUNN:

I. BACKGROUND AND REQUESTED RELIEF

In Order No. 2 entered in this case, the ALJ deemed the application for a sale, transfer or merger of facilities and certificate rights in Denton County administratively incomplete and set, as a procedural schedule, February 21, 2018, by which the applicant shall amend the application to cure the deficiencies noted by Commission Staff, and March 23, 2018, by which Commission Staff shall file a supplemental recommendation on administrative completeness.

At this time both parties request a one week extension of these two deadlines, with the applicant amending the application to cure the deficiencies noted by Commission Staff on or before February 28, 2018, and Commission Staff filing a supplemental recommendation on administrative completeness on or before March 30, 2018.
