SOAH ORDER NO. 3 EXTENDING DEADLINE FOR INTERVENTION

On May 10, 2018, the South Central Calhoun County Water Control and Improvement District No. 1 (the District) filed a letter indicating that the District and the staff (Staff) of the Public Utility Commission of Texas (Commission) agree that the notice of the hearing that the District must provide to all affected customers pursuant to 16 Texas Administrative Code § 24.41(c)(6) should provide those customers with at least 30 days to intervene in this proceeding.

Therefore, based on agreement between the District and Staff regarding the requirements of the notice of hearing, the intervention deadline in this case is **EXTENDED** to 30 days from date of issuance of the notice described below.

The District is **ORDERED** to mail the following notice to its ratepayers **no later than** three days from the date of this order:

A hearing on the merits will be convened at 9:00 a.m. on October 30, 2018, at the State Office of Administrative Hearings, 300 West 15th Street, Fourth Floor, Austin, Texas.

Any person who wants to intervene in this case (i.e., participate in this case as a party) shall file a written motion intervene at the Commission no later than thirty (30) days from the date of this notice. Any filed motion shall refer to SOAH Docket No. 473-18-2475.WS and PUC Docket No. 47912, include the person's contact information, and otherwise comply with the Commission's procedural rules. Previous submission of a protest

or signature on a petition does not meet the requirement for a person wishing to participate as a party to file a written motion to intervene as described above.
