

COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for an Extension.

I. BACKGROUND

On December 28, 2017, ratepayers (Ratepayers) of South Central Calhoun County Water Control and Improvement District No. 1 (WCID No. 1) filed a petition appealing the change in retail water rates by WCID No. 1, effective on November 1, 2017. The appeal was filed pursuant to Texas Water Code (TWC) § 13.043(b).

In Order No. 7, issued March 12, 2020, Staff was directed to file a final recommendation by March 31, 2020, and Staff and WCID No. 1 were directed to file a joint proposed order by March 31, 2020. Therefore, this pleading is therefore timely filed.

II. REQUEST FOR AN EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is currently finalizing memorandums in support of a final recommendation but needs additional time to prepare all necessary information for inclusion in the memorandum and to file a final recommendation. Staff is also currently working on finalizing a revised Joint Proposed Order with WCID No. 1 but is currently unable to file a Joint Proposed Order at this time. Therefore, Staff respectfully requests a 30-day extension in order to allow sufficient time to finalize and file a Joint Proposed Order.

III. CONCLUSION
