**ORDER NO. 4  
FINDING NOTICE SUFFICIENT AND ESTABLISHING  
PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation on notice and proposed procedural schedule. On April 26, 2018. Commission Staff stated that applicants filed proof of notice on April 17, 2018. Notice was fully completed on April 13, 2018, therefore, the 120-day deadline to approve the sale administratively or require a public hearing is August 11, 2018. Commission Staff proposed a procedural schedule based on that deadline.

Consistent with Commission Staff's recommendation, the notice is sufficient. The following procedural schedule shall apply:

Notice completed	April 13, 2018
Deadline for intervention	May 14, 2018 <sup>1</sup>
Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the certificate of convenience and necessity amendment	June 13, 2018
Deadline for parties to file a response to Commission Staff's recommendation	June 27, 2018
120-day deadline for Commission to approve the sale or require a hearing	August 11, 2018 <sup>2</sup>

<sup>1</sup> Under 16 TAC § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on April 13, 2018. Therefore, 30 days after April 13, 2018 is May 13, 2018, which is a Sunday. Therefore, under 16 TAC § 22.4(a), the intervention deadline is Monday, May 14, 2018.


<sup>2</sup> Under 16 TAC 24.109, the deadline for Commission action is 120 days after the later of either when the application is filed, when the notice was mailed, or when notice is published. Therefore, 120 days after April 13, 2018 is August 11, 2018.
