COMMISSION STAFF'S REQUEST FOR AN EXTENSION						

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing

the public interest, and files this Request for an Extension.

## I. BACKGROUND

On January 4, 2018, Sunfield Municipal Utility District No. 4 (Sunfield) filed an application to amend its water Certificate of Conveneince and Necessity (CCN) No. 13116 and for dual certification with Goforth Special Utility District (Goforth) in Hays and Travis County, Texas.

On June 13, 2018, Order No. 4 required Staff to provide final maps and certificates to the applicants for review and consent and for the applicants to file signed consent forms with the Commission by August 20, 2018. Staff timely submitted the above listed items to the applicants. Order No. 4 also requires Staff to file a final recommendation on the application on or before August 27, 2018.

#### II. REQUEST FOR AN EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Although Staff timely received a consent form from Sunfield, Staff did not receive a signed consent form Goforth on or before August 20, 2018 as required by Order No. 4. Therefore, Staff respectfully requests an extension of its August 27, 2018 final recommendation deadline to Monday, September 10, 2018 in order to allow Goforth to file the required consent form and thus facilitate continued the processing of this application.

## III. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for an extension.
