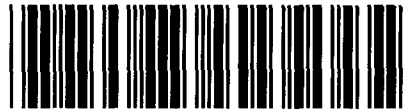

COMMISSION STAFF'S RECOMMENDATION ON NOTICE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this response to Order No. 3. In support thereof, Staff shows the following:

I. BACKGROUND

On January 9, 2018, MSEC Enterprises, Inc. (MSEC) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12887 in Montgomery County. The total area being requested includes approximately 79 acres and 1 current customer.

On May 16, 2018, MSEC filed proof of published notice and mailed notice. On May 22, 2018, MSEC filed supplemental affidavits of mailed notice.

II. NOTICE

Staff has reviewed the May 16, 2018, affidavits attesting to the mailing and publishing of notice. Additionally, Staff has reviewed the supplemental affidavit filed on May 22, 2018. Staff recommends that the Administrative Law Judge deem the notice sufficient.

IV. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Deadline for intervention	June 21, 2018
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	August 21, 2018
Deadline for Applicant to file signed consent forms with the Commission	September 5, 2018
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	September 12, 2018
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	September 19, 2018

V. CONCLUSION

For the reasons discussed above, Staff respectfully recommends that notice be found sufficient and the above procedural schedule be adopted.
