On February 6, 2018, Public Utility Commission (Commission) Staff filed its Response to Order No. 1, to which it attached a Memorandum from the Water Utility Regulation Division dated February 5, 2018, noting certain deficiencies in the maps and digital data provided by MSEC with its Application to Amend its Water Certificate of Convenience and Necessity (CCN) No. 12887, in Montgomery County (Application).

2. Attached to this filing are revised maps for the Application that address the Commission Staff's concerns as noted in the Memorandum of February 5, 2018, as follows:


- a. Revised Attachment 3.A (general location map): This revised map identifies the requested area in reference to the nearest county boundary, city, or town.

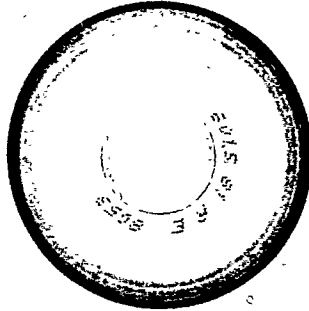
