COMES NOW, Terra Investments, LP ("Petitioner") and files this Petition with the Public Utility Commission of Texas ("PUC") for the expedited release from Aqua Texas, Inc.'s water Certificate of Convenience and Necessity ("CCN") No. 13203 pursuant to Texas Water Code §13.254(a-5) and Texas Administration Code §24.113(r), and in support thereof would respectfully show as follows:

I. LEGAL AUTHORITY

Petitioner files this petition seeking the expedited release of property owned by Petitioner in Montgomery County, Texas, from water CCN No. 13203 currently held by Aqua Texas, Inc. Pursuant to Texas Water Code §13.254(a-5) and 16 Administrative Code §24.113(r), the owner of a tract of land that is at least 25 acres and that is not receiving service may petition the PUC for an expedited release of the area from the water and sewer CCNs and is entitled to release if the property is located in certain designated counties. As more fully set out herein, Petitioner meets the legal criteria supporting the requested releases.

II. DECERTIFICATION REQUEST

In support of its request for decertification, Petitioner has attached the following documents:

Exhibit A – Affidavit of Dominic Leung

Exhibit B – Location map for the Property

Exhibit C – Large scale detailed map of Property

Exhibit D – Deed records

Exhibit E – Digital map data (CD)

Petitioner owns 384.2 contiguous acres of property in Montgomery County, Texas (the "Property"), which Petitioner seeks to decertify from water CCN No. 13203. See Exhibits A-E. The Property consists of 384.21 acres of contiguous property identified in Exhibits B-E and is greater than 25 acres. The Property is not receiving water or sewer service from Aqua Texas, Inc., or any other water or sewer provider. See Exhibit A, paragraph 5.

Petitioner requests that the PUC grant expedited release of the Property from water CCN No. 13203. The area Petitioner requests to be released consists of 3.28 acres and is depicted in Exhibits B and C and in the digital mapping data contained in Exhibit E. A copy of this Petition is being sent to Aqua Texas, Inc. by certified mail on the same day that this Petition is being filed at the PUC.

III. CONCLUSION AND PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner respectfully requests that the PUC process this Petition and release Petitioner's property from water CCN No. 13203 pursuant to Texas Water Code §13.254(a-5) and 16 Texas Administrative Code §24.113(r).

AFFIDAVIT OF DOMINIC LEUNG

BEFORE ME, the undersigned notary, personally appeared Dominic Leung, a person who is known to me. After administering an oath, the affiant testified that:

- 1. My name is Dominic Leung. I am over the age of eighteen years, of sound mind, and am capable of making this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct.
- 2. Terra Investments, LP ("Terra") owns multiple tracts of property in Montgomery County, Texas. The subject 384.2 acre tract (the "Property"), is currently burdened with 3.28 acres which lies within Aqua Texas, Inc.'s water CCN No. 13203. The subject 384.2 acre tract is over 25 acres in size and consists of the properties identified in Exhibits B E.
- 3. Terra Investments, LP, is a Texas limited partnership with its sole general partner being Accordant Holdings, LLC ("Accordant"), a Delaware limited liability company. Accordant has executed a limited power of attorney to Richfield Real Estate Corporation ("Richfield"), a Texas corporation, to manage all aspects of Terra Investments, LP's Property which is the subject of this Petition. I, in turn, am a duly authorized representative of Richfield to act on behalf of Terra pursuant to this limited power of attorney, a copy of which is attached to this affidavit. As Richfield's representative, I am familiar with Terra's properties and the bills and accounts relevant to such properties.
- 4. The exhibits attached to this Petition are as follows: Exhibit B is a true and correct copy of a map showing the location of the Property; Exhibit C is a true and correct copy of a map showing a more detailed version of the boundaries of the Property and CCN overlaps; Exhibit D reflects deed records comprising the Property; and Exhibit E reflects the required digital mapping data as well as an explanation and illustration of various parcels of land comprising the Property derived from the deed records.
- 5. The Property is not receiving water or sewer service from Aqua Texas, Inc. nor any other water or sewer service provider. There are no billing records or any other documents evidencing an existing account with Aqua Texas, Inc. for the Property. I am not aware of any lines, meters or other facilities related to the provision of water or sewer services owned or operated by Aqua Texas, Inc. on the Property.
- 6. On behalf of Terra Investments, LP, I request the Public Utility Commission of Texas to release this Property from water CCN No. 13203.




