COMMISSION STAFF'S MOTION FOR REHEARING TO CORRECT TYPOGRAPHICAL ERROR

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Commission Staff's Motion for Rehearing to correct a typographical error and would show the following:

I. PROCEDURAL HISTORY

On January 10, 2018, Terra Investments, LP (Terra) filed a petition for an expedited release from Monarch Utilities, LP's (Monarch) Sewer Certificate of Convenience and Necessity (CCN) No. 20899, in Montgomery County. Specifically, Petitioner requested for expedited release is approximately 54.86 acres. On March 1, 2018, Staff issued a final recommendation, attaching the final map and CCN certificate. On March 21, 2018, Commission Advising and Docket Management (CADM) issued a Notice of Approval. Subsequently, Terra informed the Commission that the entity was incorrectly listed on the final map and CCN certificate. Staff now timely files this motion for rehearing of the Notice of Approval under 16 Tex. Admin. Code § 22.35(d) (TAC), 16 TAC § 22.264, and Administrative Procedure Act § 2001.146.

II. REVISED STAFF RECOMMENDATION

On March 1, 2018, Staff recommended approval of Terra's application, and its attached final map and CCN certificate. Staff requests the substitution of the final map and CCN certificate attached to the final recommendation with the documents attached, which list the correct name of the entity. There are no other changes on the attached documents besides correction of the entity name.

III. REQUESTED RELIEF

Staff respectfully requests the reconsideration of the Notice of Approval, and grant Staff's request to substitute the attached final map and CCN certificate for what was filed with Staff's final recommendation, finding that good cause exists to waive the formalities of TAC § 26.111(l), based on the facts presented by Staff.


