JOINT RESPONSE TO ORDER NO. 3

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Terra Investments, LP (Terra)(collectively, the Parties), and in response to Order No. 3, files this Joint Response to Order No. 3. In support thereof, the Parties show the following:

I. BACKGROUND

On January 10, 2018, Terra Investments, LP (Terra) filed a petition for an expedited release from Monarch Utilities I, LP's (Monarch) Sewer Certificate of Convenience and Necessity (CCN) No. 20899, in Montgomery County.

On March 1, 2018, Staff issued a final recommendation, attaching the final map and CCN certificate. On March 21, 2018, Commission Advising and Docket Management (CADM) issued a Notice of Approval. Subsequently, Terra informed Staff that the entity was incorrectly listed on the final map and CCN certificate. On April 13, 2018, Staff filed a Motion for Rehearing to Correct a Typographical Error (Motion for Rehearing). On May 10, 2018, the Commission issued an order remanding the proceeding to Docket Management.

On May 17, 2018, Order No. 3 was issued, establishing a deadline of May 24, 2018, for Parties to file a verification of the proper legal name of the utility, confirmation that notice requirements have been satisfied, and confirmation that the incorrect name provided in all filings prejudiced no one. This pleading is therefore timely filed.

II. PROPER LEGAL NAME AND NOTICE

Monarch Utilities I, LP is the true and correct name of the entity which legally possesses CCN No. 20899 in this docket (Exhibit A).

Monarch received actual notice of the filing of the petition in this docket by certified mail on or about January 12, 2018 (Exhibits A and B).

As there are no affected customers, no utility-owned infrastructure within the release area, no compensation due to the utility, and proper notice was provided, no one was prejudiced based on the incorrect name in the initial and subsequent pleadings in this docket.

Except for the corrected utility name, all other representations and filings in this docket remain true and correct.

Parties respectfully request that the evidentiary record be reopened and that this, Joint Response to Order No. 3 (including attachments), be admitted into the evidentiary record.

III. CONCLUSION

For the reasons detailed above, the Parties respectfully request the re-issuance of the Notice of Approval with the substitution of the final map and CCN certificate with the corrected entity name that were attached to the Motion for Rehearing.



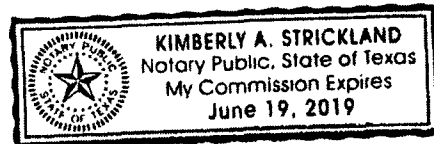
