AMERIPower, LLC 2018 SEMI-ANNUAL REPORT

AmeriPower, LLC submits its semi-annual report pursuant to P.U.C. SUBST. R. 25.107(i)(5)(B) covering the first six months of 2018. AmeriPower additionally submits the affidavit of Tejbir Singh, President and CEO, attesting to the facts represented herein. AmeriPower provides the following information as required under the rule, and agrees in advance to submit any additional information as requested by the Staff.

1. Documentation to demonstrate ongoing compliance with the financial requirements of subsection (f) of this section (SUBST. R. 25.107(i)(5)(B)(i)).

a. Letter of Credit (SUBST. R. 25.107(f)(1)(B)).

AmeriPower relies upon a letter of credit opened in its favor by its wholesale power supplier, which meets the standards of subsection (f)(4)(F). The letter was filed in Project No. 37919 on March 5, 2014 and remains in effect. AmeriPower began serving load before January 1, 2009, so it need not meet the rule's shareholder's equity provision. SUBST. R. 25.107 (f)(1)(B)(iii).

b. The amount of customer deposits and the balance of an account in which customer deposits are held (SUBST. R. 25.107(f)(2)(B)).

The amount of customer deposits are set forth in the attached bank statement for its escrow account customer deposit account, and in a separate schedule, filed under seal.

2. The audited financial statements of the REP or its guarantor for the most recent completed calendar or fiscal year (SUBST. R. 25.107(i)(5)(B)(ii)).

AmeriPower attaches its audited financial statements for the year ending December 31, 2017. AmeriPower's stock is not publicly traded, so these statements accordingly are filed under seal.

3. I further swear or affirm that AmeriPower is not in material violation of any of the requirements of its certificate.

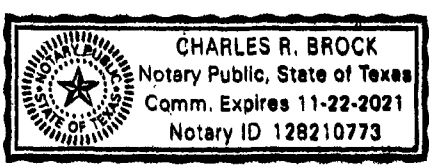


