
Dear Ms. Clark,

Please accept for filing in the above-referenced proceeding this letter and the attached affidavit as the Annual Report for Dynegy Energy Services (Texas), LLC (“Dynegy Texas”) for 2017. Dynegy Texas obtained its Retail Electric Provider (“REP”) certificate on November 8, 2017.<sup>1</sup>

There have been no changes to any of the material facts provided in, or to the financial documentation provided by Dynegy Texas in its REP application. In addition, Dynegy Texas did not serve any customers during the reporting period and has yet to complete the required Electric Reliability Council of Texas, Inc.’s flight testing. The affidavit of Sheree M. Petrone attesting to these facts is attached. Therefore, Dynegy Texas requests the Public Utility Commission of Texas accept this letter as its Annual Report pursuant to PUC Subst. R. 25.107(i)(5)(A)(vii) for 2017. Dynegy Texas also requests a good cause exception to filing the entire Annual Report to the extent such a report may otherwise be deemed necessary.

3. The financial documentation provided by Dynegy Texas in its Retail Electric Service Provider Application in PUCT Docket No. 47586 remains true and accurate.


5. Dynegy Texas did not serve any customer during the reporting period and has yet to complete flight testing with the Electric Reliability Council of Texas, Inc.
