STATUS REPORT NO. 6

COMES NOW Liberty Utilities (Silverleaf Water) LLC ("Liberty Silverleaf") and, together with Commission Staff ("Staff"), City of Tyler ("Tyler"), Silverleaf Resorts, Inc. ("SRI"), Holly Lake Rach Association ("HLRA"), Liberty Residential Water Association ("LRWA"), Office of Public Utility Counsel ("OPUC"), (collectively, the "Parties"), file this Status Report No. 5. In support, Liberty Silverleaf respectfully shows the following.

On March 19, 2018, Liberty Silverleaf filed its application to change water and sewer rates. SOAH Order No. 13 (January 8, 2019) Granting Unopposed Motion to Abate canceled the scheduled hearing on the merits, abated the proceeding, and set a deadline of January 25, 2019 for parties to file a status report. The Parties have filed several status reports since then, the last of which was filed on April 18, 2019, and filed their Joint Notice of Stipulation on May 6, 2019. This status report is timely filed pursuant to SOAH Order No. 18 (April 23, 2019).

The Parties need additional time to prepare final documents needed to implement their May 6, 2019 settlement agreement. Therefore, the Parties request to continue the abatement of this docket for that purpose until May 17, 2019. On or before May 17, 2019, the Parties will file a status report with the Court informing the Honorable ALJ of the status of their settlement efforts or file their documents needed to resolve this case without a hearing.



PRAYER

Wherefore, premises considered, Liberty Silverleaf, Staff, OPUC, the City of Tyler, SRI, LRWA, and HLRA respectfully requests that Your Honor(s) issue an order continuing abatement of the case, approving the schedule, and for any further relief for which the Parties and Staff may be entitled.
