
**SILVERLEAF RESORTS, INC.'S REPLY TO LIBERTY RESIDENTIAL WATER  
ASSOCIATION'S FIRST REQUEST FOR INFORMATION**

COMES NOW Silverleaf Resorts, Inc. (“SRI”) and files its responses to Liberty Residential Water Association’s (“LRWA’s”) first Request for Information (“RFI”). LRWA served its first RFIs on July 23, 2018. Pursuant to agreement between Counsel, these responses are timely filed.

Counsel for SRI and LRWA discussed limitations on LRWA’s served RFIs in connection with SRI’s potential objections. Following that discussion, LRWA narrowed the scope of RFIs 1-1 and 1-2, which is discussed in the body of SRI’s attached responses. In addition, LRWA withdrew RFIs 1-7, 1-8, 1-9, and 1-10. Accordingly, SRI does not attach responses to those RFIs. SRI and LRWA agreed to an extension to the portions of LRWA 1-1 and 1-2 that ask for “all correspondence,” and SRI will supplement its responses to these RFIs with relevant information once the searches are complete.

**Silverleaf Resorts, Inc.'s Response to LRWA's First Request for Information**

**LRWA RFI 1-1:**

What is/are the nature of SRI's relationship/s to Liberty Silverleaf directly, indirectly or otherwise? Provide a chronology of each relationship from inception. Include all correspondence to or from Liberty Silverleaf since inception.

**RESPONSE:** SRI objects this RFI subject to its objection, SRI answers as follows:

SRI (1) pays water and sewer rates to Liberty Silverleaf and (2) has existing contractual arrangements with Liberty Silverleaf, as described below.

**Ratepayer**

Prior to August 29, 2004, SRI owned utility assets that provided water and wastewater service to four of its resort properties in Texas, including Holly Lake Ranch, Big Eddy, Piney Shores and Hill Country. On August 29, 2004, SRI conveyed to Algonquin Water Resources of Texas, Inc., the predecessor in interest of Liberty Silverleaf, all of these utility assets in the Asset Purchase Agreement. Since that time, SRI has taken service from Liberty Silverleaf and is a ratepayer under the applicable tariffs.

**Contract**

In 2010, SRI sought to expand the number of units at its Hill Country Resort. In order to obtain final platting from Comal County, it entered into a contract with the Guadalupe Blanco River Authority ("GBRA") to obtain an additional 80,000 gallons per day of wastewater treatment capacity. In exchange, SRI spent \$2.245 million constructing expanded facilities at GBRA's Canyon Lake treatment plant. SRI by separate agreement conveyed to Liberty Silverleaf this additional 80,000 gallons per day of wastewater treatment capacity acquired from GBRA. Rather than pay SRI directly for this additional treatment capacity, Liberty Silverleaf on July 30, 2010, in what is titled the "Wastewater Extension Agreement" agreed to reimburse SRI for its \$2.245 million in capital investment in new treatment facilities as soon as it was able to include that capital investment in its rate base, and agreed to file a rate case to achieve this result "at the earliest possible date." Parallel to this agreement and executed on the same day, July 30, 2010, an affiliate of Liberty Silverleaf, Liberty Water Company, entered into the Note and Credit Agreement that loaned to SRI the \$2.245 million SRI had previously incurred to build facilities at the Canyon Plant. The Note and Credit Agreement was intended to work in tandem with the Wastewater Extension Agreement in that as soon as Liberty Silverleaf included the \$2.245 million in rates, it would pay SRI for that amount. SRI would then transfer this amount to Liberty Silverleaf's affiliate, which would in turn extinguish the principal under the Note and Credit Agreement. Until

such time as Liberty Silverleaf sought and received approval of including the \$2.245 million in rate base, SRI was obligated to pay Liberty Silverleaf 15% in interest under the Note and Credit Agreement. This case filed in 2018 is the first case filed by Liberty Silverleaf for these systems since those agreements were executed more than eight years ago.

The Asset Purchase Agreement, Wastewater Extension Agreement and Note and Credit Agreement were included with Liberty Silverleaf's rate filing package in this docket. SRI will supplement this response with available relevant correspondence related to these agreements. Please note that the scope of LRWA's request for "all" correspondence "since inception" was limited in discussions between counsel for LRWA and SRI.

- i. The “Capital Plan” was generally an item of discussion at quarterly meetings between representatives of SRI and Liberty. These discussions typically addressed new developments planned during the preceding 12 months. Liberty has produced copies of the minutes from these quarterly meetings in response to LRWA 1-1 (Bates nos. LU 006624-LU 006784).
- ii. Service requests were generally made by email, and plans were sent to Liberty for review and approval. Budgets for these requests would be discussed during the quarterly meeting ahead of the service requests. Liberty would also inspect all line extensions and approve them before accepting them as a new asset.
- iii. “Excluded investments” in Schedule 7.06 refers to those categories of plant that the state regulator in Missouri does not allow to be included in rate base, as set out in the matrix in the “Purchaser Funded Eligibility” section of Schedule 7.06.

Admit or Deny: Piney Shores and/or Hill Country water systems, on a stand-alone basis, are not “Public Water Systems” as defined by [30 TAC §290.38(71), Fed Ref]?

- a. Reconcile your response with Mathew Garlick’s sworn testimony at LU 000242 Lines 11 and 18.
- b. By respective subdivision (8110-Holly Ranch, 8112-Big Eddy, 8114-Piney Shores, and 8116-Hill Country), provide a schedule of the number of water connections attributed to SRI and/or OLR at December 31 of each year since the sale of the water systems to Algonquin.

**RESPONSE:**

Deny.

- 4(a) The Hill Country water system on a stand-alone basis serves more than 25 individuals for at least 60 days out of the year, which is the standard for a public water system in 30 TAC §290.38(71). In addition, payment for water and sewer service in both the Hill Country Resort and Piney Shores Resort is ultimately borne by the hundreds of time share owners at each of these resorts, which SRI believes matches the intent of the rule. Finally, these water systems also meet the definition of “water and sewer utility” as set forth in 16 TAC §24.3(73), which is the legal definition applicable to the assertion of regulatory jurisdiction in this case.
- 4(b) See attached Exhibit LRWA 1-4. Please note that some connections provide both water and sewer service, while others provide only water.
