COMMISSION STAFF'S SUPPLEMENTAL FINAL RECOMMENDATION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Supplemental Final Recommendation. Staff recommends that the application be approved. In support thereof, Staff shows the following:

I. BACKGROUND

On January 23, 2018, the City of Heath (Heath) filed an application to amend water certificate of convenience and necessity (CCN) No. 12060 to provide water service to the Forney Lake Water Supply Corporation's (FLWSC) CCN area and to decertify a portion of FLWSC's CCN No. 10086 in Rockwall and Kaufman counties.

Staff filed a recommendation on final disposition on April 30, 2018. On May 9, 2018, Heath filed a Joint Motion to Admit Evidence and Proposed Notice of Approval, which included a joint motion to admit Staff's April 30, 2018 final recommendation along with the attached final map and certificates into the record of the proceeding.

II. SUPPLEMENT TO FINAL RECOMMENDATION

The final map and certificates were inadvertently not filed along with Staff's final recommendation on April 30, 2018. They are attached to this pleading.

III. MOTION TO ADMIT EVIDENCE

Staff moves for the final map and certificates be admitted into the record of this proceeding either as incorporated with the final recommendation filed on April 30, 2018, or in this separate pleading.

IV. CONCLUSION

For the reasons detailed above, Staff recommends that the application be approved and moves for the attached map and certificates to be admitted into the record of this proceeding.


