NOTICE OF APPROVAL

This Notice addresses the application of the City of Heath (Heath) to amend certificate of convenience and necessity (CCN) No. 12060 and for decertification of an area in Rockwall and Kaufman counties served by Forney Lake Water Supply Corporation (Forney Lake WSC) (collectively, applicants) under CCN No. 10086. Commission Staff recommends approval of the application, as supplemented. The Commission approves the application, as supplemented.

The Commission adopts the following findings of fact and conclusions of law:

I. Findings of Fact

Procedural History

1. On January 23, 2018, Heath filed an application for single certification to an area in its corporate limits within Forney Lake WSC's service area.
2. Heath and Forney Lake WSC have agreed to transfer certain service area as well as existing lines and easements from Forney Lake WSC to Heath. The applicants filed a written agreement with the application.
3. The total proposed service area requested in this application consists of approximately 2,601 acres and 839 current customers.
4. In Order No. 1 issued on January 25, 2018, the administrative law judge (ALJ) required Commission Staff to comment on the administrative completeness of the application and the proposed notice.

5. On February 5, 2018, Heath supplemented the application with a transmittal letter describing the monetary compensation agreed to by applicants and the conveyance of Forney Lake WSC's real and personal property along with lines, appurtenances, and easements.
6. On February 16, 2018, Heath supplemented the application with corrections to the maps submitted with the application.
7. On February 23, 2018, Commission Staff recommended that the ALJ deem the application administratively complete.
8. In Order No. 2 issued on February 26, 2018, the ALJ found the application administratively complete and required Heath to provide notice consistent with Commission Staff's recommendation.
9. On February 26, 2018, Commission Staff recommended that the ALJ deem notice sufficient.
10. In Order No. 3 issued on February 28, 2018, the ALJ found the notice sufficient.
11. On April 16, 2018, Heath filed a signed consent form concurring with the proposed map and certificate prepared by Commission Staff.
12. On April 30, 2018, Commission Staff recommended approval of the application.
13. On May 9, 2018, Commission Staff and the applicants filed a joint proposed notice of approval and motion to admit evidence.
14. On May 14, 2018, Commission Staff filed a supplement to the final recommendation attaching the certificates and map inadvertently omitted from the May 9 filing.
15. In Order No. 4 issued on May 9, 2018, the ALJ admitted evidence into the record.
16. On June 26, 2018, Commission Staff filed a supplement to the final recommendation correcting the certificate submitted with the May 14, 2018 filing.

Notice

17. Notice of the application appeared in the February 9, 2018, issue of the *Texas Register*.

18. Prior to filing the application, Heath and Forney Lake WSC held public meetings at which their respective governing bodies discussed and approved the agreement.

Informal Disposition

19. More than 15 days have passed since the completion of the notice provided in this docket.
20. Commission Staff and the applicants are the only parties to this proceeding.
21. No persons filed protests or requests for hearing.

II. Conclusions of Law

1. The Commission has jurisdiction over this matter under § 13.255 of the Texas Water Code (TWC).¹
2. Heath owns and operates a municipally-owned utility as defined in TWC § 13.002(13).
3. Heath is entitled to approval of the application having demonstrated that the service area requested in this application is within Heath's corporate limits and having provided a copy of the agreement with Forney Lake WSC, which states that Heath may serve all of the requested area, consistent with TWC § 13.255(a).
4. The application was processed in accordance with TWC § 13.255 and Commission rules.
5. Under TWC § 13.257(r) and (s), the applicants are required to record a certified copy of the approved CCN and map, along with a boundary description of the service area in the real property records of Rockwall and Kaufmann counties, in which the service area or a portion of the service area is located, and submit to the Commission evidence of the recording.
6. The application meets the requirements for informal disposition in 16 TAC § 22.35.

III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following order:


1. The Commission approves the application, as supplemented.

2. The Commission admits into the record and approves the certificates and map attached to this Notice.
3. The Commission amends CCN Nos. 12060 and 10086 to reflect the agreement between Heath and Forney Lake WSC.
4. Heath shall serve every customer and applicant for service within the areas under its CCN, and such service shall be continuous and adequate.
5. Heath shall comply with the recording requirements in TWC § 13.257(r) and (s) for the area in Rockwall and Kaufman counties affected by the application and submit to the Commission evidence of the recording no later than 31 days after receipt of this Notice.
6. Forney Lake WSC shall continue to serve every customer and applicant for service within the areas still under its CCN, and such service shall be continuous and adequate.
7. Forney Lake WSC shall comply with the recording requirements in TWC § 13.257(r) and (s) for the area in Rockwall and Kaufman counties affected by the application and submit to the Commission evidence of the recording no later than 31 days after receipt of this Notice.
8. All other motions and any other requests for general or specific relief, if not expressly granted, are denied.

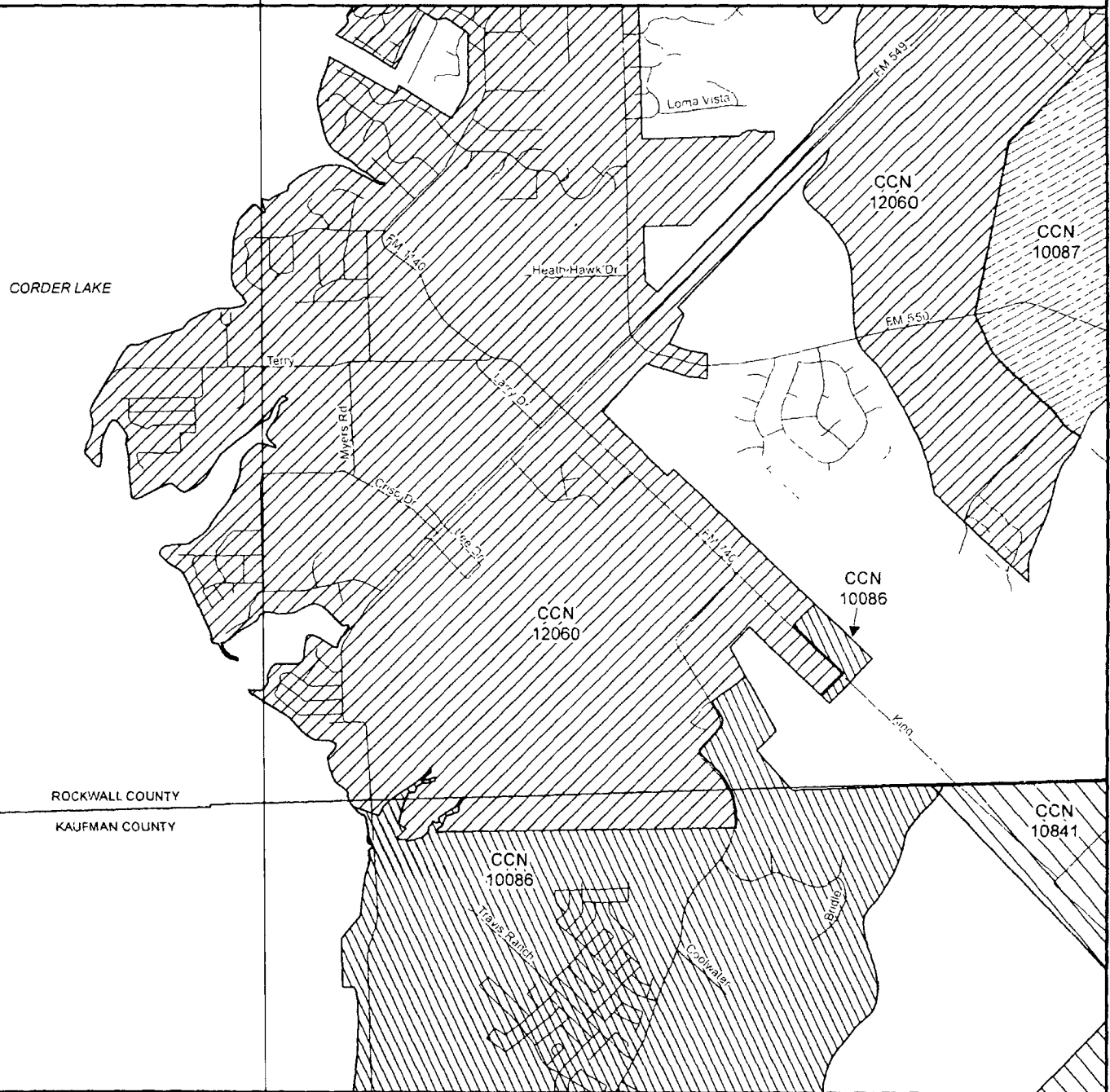
