Enclosed you will find seven (7) copies of our "Petition to Appeal Rates Established by the Board of Directors, Galveston County M.U.D. District No. 12" as outlined in the sample petition of the "Utili-Facts" publication furnished by the PUC of Texas, including the original copy. We have sent a copy to the Galveston County M.U.D. District No. 12, and we have retained two (2) copies for our file. We are told there are 1,450 water and sewage treatment customers in our District 12. We have gathered 207 signatures after reviewing them for duplicates and/or errors.

The purpose of this appeal is to contest the \$30.00 per ratepayer invoice flat rate increase imposed by M.U.D. District No. 12 beginning with the December 2017 invoice. This rate increase followed a failed local bond request \$17.4M and vote by a margin of 4 to 1. District No. 12 again requested \$17.4M in the Galveston County General Bond Election which failed by a margin of 2 to 1. The bond requests failed because of lack of scope (definition) and time line. In addition \$10M of the \$17.4M (58%) of the request is not within the definition of water related service, though it is within the responsibility of District No. 12 to maintain. These other projects need to be covered by Reserve Accounts set up for such a purpose. We, the ratepayers, believe the purpose of imposing the \$30.00 per month flat rate by District No. 12 is only a way to get around the Bond request failures and the demands of the ratepayers for definition and transparency.

We, the ratepayers, do not dispute the equipment maintained by District No. 12 needs repairs, maintenance, and replacement from time to time. The ratepayers dispute the lack of definition of spending of the requested funds within the Bond request. The \$30.00 per month increase generally increased rates by a margin of over 70%, depending on the volume of water and waste treatment each ratepayer uses. Ratepayers were not notified prior to this flat rate increase. A letter (which was not dated or signed) was received December 22, 2017 in an attempt to identify and justify the \$30.00 per month rate increase, after the fact. It should be noted that this letter did not offer information to identify and justify the bond request or definition of spending and timeline.

Our Galveston County M.U.D. District No. 12 services two subdivisions to furnish fresh water and provide treatment of sewage. These two subdivisions are located in two separate cities though located across Highway #6 from one another. The Omega Bay Subdivision is located within the City of La Marque, TX 77568. The Bayou Vista Subdivision is located within the City of Hitchcock, TX 77563. When the Petition was


printed, we neglected to specify all ratepayers provide the City, State, and Zip Code with their signature. To this end we have enclosed a copy of the maps for Omega Bay and for Bayou Vista printed from Google Maps. We have also enclosed a list of the streets for each subdivision for easier reading.

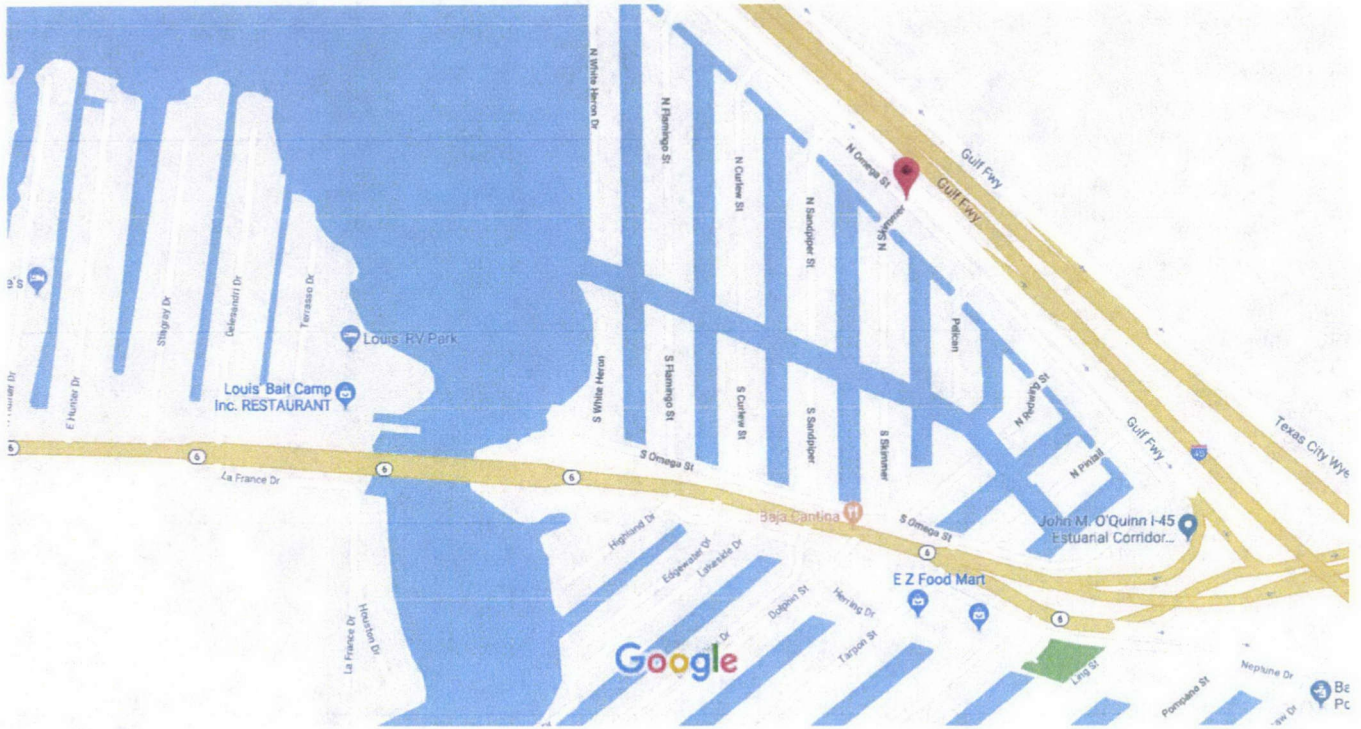

The undersigned ratepayers of The Galveston County M.U.D. District No. 12 hereby appeal the decision of The Board of Directors affecting the rates charged to them by The Galveston County District No. 12. The rate change was effective November 13, 2017 and affected the rates charged for water utility service, waste water utility service and the TCEQ fee. The ratepayers were never notified of this rate increase. The rate increase was assessed in the December Billing without detail after two bond request failures. The undersigned request that the Public Utilities Commission of Texas review the decision to determine if the rates established are just and reasonable. The bond request failed two elections because of lack of scope & time line plus \$10M of the \$17M requested or 58% is believed to be outside water service definition. To this end M.U.D. District No. 12 increased water bills by a flat rate of \$30 with no explanation.

The undersigned designate the Omega Bay Improvement Committee (OBIC) as their representative on this mater.
