RATEPAYERS' APPEAL OF THE DECISION BY GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 12 TO CHANGE RATES BEFORE THE STATE OFFICE OF

SOAH ORDER NO. 4 GRANTING MOTION FOR CONTINUANCE, AMENDING PROCEDURAL SCHEDULE, AND RESETTING HEARING

Following the filing of an agreed procedural schedule, the Administrative Law Judge (ALJ) set the hearing in this matter on October 2, 2018. On July 3, the parties filed an agreed motion to continue the hearing date and amend the procedural schedule. The ALJ finds the motion has merit. The hearing currently scheduled on October 2-4, 2018, is cancelled.

The hearing on the merits will convene at 9:00 a.m., on November 5-7, 2018, at the State Office of Administrative Hearings, 300 West 15th Street, 4th Floor, Austin, Texas. It is set for three days. The amended schedule is adopted as follows:
