**SOAH ORDER NO. 4  
GRANTING MOTION FOR CONTINUANCE, AMENDING PROCEDURAL

Following the filing of an agreed procedural schedule, the Administrative Law Judge (ALJ) set the hearing in this matter on October 2, 2018. On July 3, the parties filed an agreed motion to continue the hearing date and amend the procedural schedule. The ALJ finds the motion has merit.
