- (4) IF THE DOCUMENTS ARE DELIVERED TO SOAH'S DOCKETING OFFICE, THEY SHOULD BE ENCLOSED IN A SEALED ENVELOPE, CLEARLY MARKED "CONFIDENTIAL MEDIATION INFORMATION," WITH THE DOCKET NUMBER AND THE MEDIATOR'S NAME CLEARLY DISPLAYED ON THE ENVELOPE.
