Dear TCEQ Staff:

Enclosed for your review and comments is one (1) set of plans and specifications for the proposed water facility improvements to the Red River Authority of Texas Hinds-Wildcat Water System. The purpose of this project is to provide the Hinds-Wildcat & Northside Water System with a new water supply that fully complies with the water quality standards regulated by the Texas Commission on Environmental Quality (TCEQ) and the Environmental Protection Agency (EPA) as mandated by an EPA Administrative Order (Docket Number: SDWA-06-2013-1236).

The proposed project generally includes the construction of a 8" PVC transmission line (approximately 21,000 linear feet), 6" PVC transmission line (approximately 31,000 linear feet), two pump stations, metering facilities, and associated valves (refer to enclosed Design Memorandum). These improvements will convey treated water from the City of Vernon to the new Hinds-Wildcat Pump Station. This pump station will then provide/convey water to the Hinds-Wildcat distribution system and the new Northside Pump Station.
