This letter is to inform you that CBWS is requesting a minor tariff adjustment for the District Fees paid to Northern Trinity Groundwater Conservation District. These Fees are for the Bear Creek Subdivision Only .PWS # 2200336 located in Tarrant County. Texas. The Water District has been charging these fees since 2011. According to Ms. Kathryn Eiland, of the PUC, the formula is as follows:

#### R=G/1-L

R = New Rate G = Gallonage Charge from District L = Actual Line Loss

For the purpose of equating a new total to be charged the valuations are as follows

#### G = .125 L = 20.6666 or .21


L for this computation was derived from an average of the most recent 6 months of data. The previous 5 months which are included seemed skewed because 2 months showed negative loss and one month was a compiled average of all the systems. The individual report was not printed that month for unknown reasons ,but the most recent 6 months give a distinct percentage base with which to work. The full year of data was not available due to computer failure in March of 2016. Using those figures

#### R = \$0.158 or \$0.16

CBWS is requesting a minor tariff change affecting only the Bear Subdivision, located in Tarrant County of \$0.16/ 1000 gals. In addition to the already approved amount of \$3.60 / 1000 gals. To be added to CBWS's tariff.


