COMMISSION STAFF'S SECOND REQUEST TO AMEND PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Second Request to Amend Procedural Schedule and would show the following:

I. BACKGROUND

On February 7, 2018, Crystal Springs Water Company, Inc. (Crystal Springs) filed a petition to amend its water Certificate of Convenience and Necessity (CCN) No. 11373 in Montgomery County. Specifically, Crystal Springs requests a total service area of approximately 102 acres with zero current customers. Order No. 6, issued June 12, 2018, granted Staff's first request to amend the procedural schedule and set August 2, 2018, as the new deadline for Commission Staff to provide final maps and certificates to Crystal Springs. Therefore, this pleading is timely filed.

II. REQUEST TO AMEND

Staff respectfully requests that the Administrative Law Judge modify the procedural schedule to give Staff additional time to process the application. Under 16 Texas Administrative Code (TAC) § 22.144(c), Crystal Springs' responses to Staff's second set of requests for information was due on June 25, 2018. The responses were not filed until July 9, 2018, and Staff needs time to review the responses and prepare the final map and other documents for Crystal Springs' consent. Staff has contacted a representative of Crystal Springs who stated that Crystal Springs is not opposed to this request.



III. AMENDED PROCEDURAL SCHEDULE

Staff proposes the following amended procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Crystal Springs for review and consent	August 23, 2018
Deadline for Crystal Springs to file signed consent forms with the Commission	September 6, 2018
If no hearing is requested, deadline for Staff to file a final recommendation on the application	September 13, 2018
If no hearing is requested, deadline for Crystal Springs to file joint proposed findings of fact and conclusions of law	September 20, 2018

IV. CONCLUSION

Staff respectfully requests the entry of an Order adopting the amended procedural schedule proposed above.
