AGREED REQUEST FOR ABATEMENT

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Agreed Request for Abatement and would show the following:

I. BACKGROUND

On February 7, 2018, Crystal Springs Water Company, Inc. (Crystal Springs) filed a petition to amend its water Certificate of Convenience and Necessity (CCN) No. 11373 in Montgomery County. Specifically, Crystal Springs requests a total service area of approximately 102 acres with zero current customers. Order No. 8, issued September 7, 2018, granted Staff's third request to amend the procedural schedule and set September 20, 2018, as the deadline for Staff's final recommendation on the application. In lieu of a final recommendation, Staff files this Agreed Request for Abatement.

II. STAFF'S REQUEST

Staff respectfully requests that the Administrative Law Judge abate this proceeding for 90 days to give Crystal Springs additional time to obtain approval of the plans for the water distribution system included in this application from the Texas Commission on Environmental Quality (TCEQ). On or before December 19, 2018, Staff will file a final recommendation on the application or a status report. Staff has contacted a representative of Crystal Springs who stated that Crystal Springs agrees with this request.

III. CONCLUSION

Staff respectfully requests the entry of an order abating this proceeding for 90 days.
