

APPLICATION OF QUADVEST, L.P. TO AMEND ITS CERTIFICATE OF CONVENIENCE AND NECESSITY IN FORT BEND COUNTY

### COMMISSION STAFF'S MOTION TO AMEND PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Motion to Amend Procedural Schedule, and would show the following:

#### I. BACKGROUND

On February 7, 2018, Quadvest L.P. (Quadvest or Applicant) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11612 and sewer CCN No. 20952 in Fort Bend County. The total area being requested includes approximately one hundred eight (108) acres and zero (0) current customers.

Previously, on December 27, 2017, in Docket No. 47910, Quadvest filed an application to amend its water CCN No. 11612 and sewer CCN No. 20952, and to decertify a portion of another CCN holder's water service area in Harris County. On October 1, 2019, the Notice of Approval was issued in Docket No. 47910. Thereafter, on October 23, 2019, a clean copy of the tariff was filed in the docket.

At the time of Staff's most recent request to amend the procedural schedule, the parties in the present docket were only awaiting the approval of Quadvest's application in Docket No. 47910. However, after further review, Staff has determined that other Quadvest water and sewer matters must first be reconciled, including five pass-through rate change applications, Docket Nos. 49124, 49213, 49214, 49215, 49216, and one water and sewer CCN amendment application, Docket No. 48303.

On June 27, 2018, Order No. 5 was issued in this docket, No. 48034, establishing a deadline for Staff to provide final maps, certificates, and tariffs to the Applicant for review and consent by August 8, 2018.

On September 5, 2019, Order No. 13 was issued in this docket, No. 48034, granting Commission Staff's eighth request to amend the procedural schedule since there was no current

base tariff upon which Staff could rely to implement the revisions requested in Applicant's application. Order No. 13 also reset the deadline for Staff to provide final maps, certificates, and tariffs to the Applicant for review and consent to October 29, 2019. Therefore, this pleading is timely filed.

### II. AMENDED PROCEDURAL SCHEDULE

The parties in the present docket await the resolution of other Quadvest water and sewer applications, specifically, Docket Nos. 49124, 49213, 49214, 49215, 49216, and 48303. Until the tariffs in the aforementioned dockets are reconciled, Staff has no current base tariff that can be used to implement the revisions requested in the subject application. Therefore, Staff requests an additional twelve-week extension to its deadline to provide final maps, certificates, and tariffs, in order to allow for the potential approval of the tariffs in Quadvest's other pass-through and CCN amendment dockets. The remaining deadlines are also advanced accordingly. Staff's request would result in the following modifications to the procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Applicant for review and consent	January 21, 2020
Deadline for Applicant to file signed consent forms with the Commission	February 4, 2020
If no hearing is requested, deadline for Staff to file a final recommendation on the application	February 11, 2020
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	February 18, 2020

Staff has contacted Quadvest regarding the amended procedural schedule, and Quadvest agrees with the proposed dates.
