COMMISSION STAFF'S REQUEST FOR AN AMENDED SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for an Amended Schedule and would show the following:

I. BACKGROUND

On February 12, 2018, Quadvest, L.P. (Quadvest) filed an application for a minor change to its tariff under water Certificate of Convenience and Necessity No. 11612. Quadvest seeks to increase its pass-through rate from \$3.32 to \$3.35 per 1,000 gallons as a result of an increase to the well pumpage fees charged by North Fort Bend Water Authority. The rate increase will apply to the Lake Pointe Estates subdivision and will take effect on March 19, 2018.

On March 26, 2018, the Administrative Law Judge (ALJ) issued a Notice requiring Quadvest to file supplemental information to cure the deficiencies in the application, including proof that revised notice was sent to customers, by April 2, 2018. The ALJ also ordered Staff to file a supplemental recommendation on sufficiency of the application and notice no later than May 2, 2018.

Quadvest filed its supplemental information in the wrong docket—Docket No. 48051. Specifically, the documents from AIS Item Nos. 3 and 7 in Docket No. 48051 should have been filed in this docket and vice versa. Staff has contacted a representative of Quadvest who stated that Quadvest is not opposed to this request.

II. REQUEST FOR AMENDED SCHEDULE

Staff respectfully requests that the ALJ modify the procedural schedule to give Quadvest until May 9, 2018, to properly file the supplemental information. Staff additionally requests that the deadline for Staff's supplemental recommendation be moved to March 16, 2018.
