**ORDER NO. 5  
APPROVING TRANSACTION TO PROCEED**

This Order addresses DJL Ventures, Inc. d/b/a KAP Water Supply and SWWC Utilities, Inc. d/b/a Water Services, Inc.'s (collectively, applicants) application for the transfer of service area rights in Comal County.

The administrative law judge (ALJ) finds the transaction proposed in this application may proceed and be completed. As soon as possible after the effective date of the transaction, but not later than 30 days after, Applicants must file proof the transaction has been completed.<sup>1</sup> Commission Staff recommends that the administrative law judge (ALJ) find the transaction proposed in this application may proceed and be completed. As soon as possible after the effective date of the transaction, but not later than 30 days after, the applicants are required to file proof that the transaction has been consummated. There are no remaining deposits to be addressed. SWWC is required to submit copies of the Texas Commission on Environmental Quality (TCEQ) approval letters associated with the public water system improvements detailed in their response to Commission Staff's request for information ten days prior to the submission of closing documents.

Applicants have 180 days to complete the transaction.<sup>2</sup> If the transaction is not completed within this period, this approval is void, unless the Commission in writing extends the time period for good cause shown.<sup>3</sup> Applicants are advised that the certificate affected by this application will continue to be held by DJL until this application is complete in accordance with the Commission's rules and final approval is issued.



In an effort to finalize this case as soon as possible, beginning September 15, 2018, and continuing monthly thereafter, the applicants must file an update regarding the status of the efforts to conclude the transaction and submit documents evidencing the transaction was completed. Applicants must submit copies of the TCEQ approval letters ten days prior to the submission of closing documents.

Within 15 days following the filing of the applicants' proof that the transaction has been completed. Commission Staff is required to file a recommendation regarding the sufficiency of the documents and propose a schedule for the continued processing of this docket.
