COMMISSION STAFF'S REQUEST TO REVISE PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request to Revise Procedural Schedule in response to Order No. 2 and would show the following:

I. BACKGROUND

On February 23, 2018, Lester Brown II filed a petition with the Public Utility Commission of Texas (Commission) appealing the decision of Paint Creek Water Supply Corporation (Paint Creek) for the cost of obtaining service. This appeal is governed by Tex. Water Code § 13.043(g) (TWC) and 16 Texas Administrative Code (TAC) § 24.41(g). Mr. Brown stated that the total cost to obtain service from Paint Creek was \$102,000, which includes \$2000 for a feasibility study.

On March 27, 2018, Order No. 2 was issued, establishing a deadline of May 25, 2018, for Staff to file a final recommendation on the petition or request a hearing. This pleading is therefore timely filed.

II. REQUEST TO REVISE PROCEDURAL SCHEDULE

Staff has reviewed the petition and determined that the record needs further development before a determination on the merits of the petition can be made. In addition, Paint Creek has not filed a response to the petition. Staff therefore requests that the procedural schedule in this case be revised as follows to allow additional time for Paint Creek to file a response, if it so desires, and for Staff to conduct discovery and analyze the responses received.

III. CONCLUSION

For the reasons detailed above, Staff requests that the procedural schedule in this matter be revised to allow Paint Creek additional time to file a response, if it desires, and to allow Staff additional time to conduct discovery and analyze the responses received.
