COMMISSION STAFF'S REQUEST TO REVISE PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request to Revise Procedural Schedule in response to Order No.4. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2018, LGRVR Water Supply Corporation (LGRVR WSC or Purchaser) and Fall Creek Utility Company, Inc. (Fall Creek or Seller) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate rights in Hood County, Texas. Specifically, LGRVR WSC seeks approval to acquire facilities and to transfer Fall Creek's water and sewer service area under Certificate of Convenience and Necessity (CCN) Nos. 12884 (water) and 20854 (sewer). The requested area includes approximately 22 acres and 71 water and 69 sewer connections.

On June 5, 2018, Order No. 4 was issued, authorizing the Applicants to proceed with the transaction and establishing a deadline of 15 days from the filing of proof of sale documentation for Staff to file a recommendation on the sufficiency of the documentation and propose a procedural schedule for further processing. Applicants filed proof of sale documentation on December 21, 2018. Fifteen days from December 21, 2018 is January 5, 2019. However, it is Staff's understanding that the Applicants will be filing a supplement to their December 21, 2018 documents.

II. REQUEST TO REVISE PROCEDURAL SCHEDULE

Staff has conferred with Applicants, and it is Staff's understanding that by January 11, 2019, Applicants will be submitting a supplement to their December 21, 2018 filing to further explain the handling of customer deposits. Staff therefore respectfully requests that

Staff's recommendation on sufficiency of sale documents be due within five working days of when that supplement is filed.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests that Staff's recommendation on sufficiency of sale documents be due within five working days of when Applicants file their supplement to their December 21, 2018 filing.
