SUPPLEMENTAL JOINT MOTION TO ADMIT EVIDENCE

COME NOW the Staff of the Public Utility Commission of Texas (Staff), Fall Creek Utility Company, Inc. (Fall Creek), and LGRVR Water Supply Corporation (LGRVR) (collectively, the Parties) and jointly file this Supplemental Motion to Admit Evidence. In support thereof, the Parties show the following:

I. BACKGROUND

On February 28, 2018, the Fall Creek and LGRVR filed an application with the Public Utility Commission of Texas (Commission) for sale, transfer, or merger of facilities and certificate rights in Hood County, Texas. Specifically, LGRVR seeks approval to acquire facilities and to transfer Fall Creek's water and sewer service area under Certificate of Convenience and Necessity (CCN) Nos. 12884 (water) and 20854 (sewer). The requested area includes approximately 22 acres and 71 water and 69 sewer connections.

On April 26, 2019, Order No. 9 was issued, directing LGRVR to file its tariffs with the Commission and establishing a deadline of May 22, 2019, for the parties to file a joint motion to admit the tariffs as evidence. This pleading is therefore timely filed.

II. MOTION TO ADMIT EVIDENCE

On May 8, 2019, LGRVR timely filed its tariffs. The Parties hereby move that the tariffs be admitted into the evidentiary record of this proceeding.

III. CONCLUSION


The Parties respectfully request that LGRVR's tariffs be admitted into the record of this proceeding as evidence.


