UNDINE TEXAS ENVIRONMENTAL, LLC'S RESPONSE TO ORDER NO. 2

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Undine Texas Environmental, LLC ("Undine") files this Response to Order No. 2. In support thereof, Undine states the following:

I.

BACKGROUND

On March 8, 2019, Bolivar Utility Services, LLC ("Bolivar") and Undine (collectively "Applicants") filed with the Public Utility Commission of Texas ("Commission") an application for sale, transfer, or merger of facilities and Certificate of Convenience and Necessity ("CCN") rights in Galveston County, Texas (the "Application").

On March 12, 2018, the Administrative Law Judge ("ALJ") issued Order No. 1 requiring Commission Staff to file its recommendation regarding the administrative completeness of the Application by April 9, 2018.

On April 9, 2018, Commission Staff filed their Recommendation on Administrative Completeness. Commission Staff recommended that Applicants be given until May 9, 2018 to cure the identified deficiencies in the Application and that Commission Staff be given until May 30, 2018 to file a supplemental administrative completeness recommendation.

On April 11, 2018, the ALJ issued Order No. 2 finding that the Application was deficient and incomplete for the reasons specified in the pleading and memorandum of Sean Scaff in the Commission's Water Utility Regulation Division.

II.

In response to Order No. 2, Undine hereby files the following information.
