ORDER NO. 4 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the application of Bolivar Utility Services, LLC and Undine Texas Environmental, LLC for a sale, transfer, or merger of facilities and certificate rights in Galveston County. Applicants filed proof of notice and fully completed notice on September 28, 2018.

The administrative law judge finds the notice sufficient and adopts the following procedural schedule.

Event	Date
Deadline to intervene	October 29, 2018 ¹
Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and on the certificate of convenience and necessity amendment	November 28, 2018
Deadline for parties to file a response to Commission Staff's recommendation	December 12, 2018
120-day deadline for Commission to approve the sale or require a hearing	January 28, 2019 ²

¹ Under 16 Texas Administrative Code (TAC) § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on September 28, 2018. Therefore, 30 days after September 28, 2018 is Sunday, October 28, 2018. Since the Commission is closed, the period runs until the end of the next day on which the Commission is open for business, Monday, October 29, 2018.

² Under 16 TAC § 24.109, the deadline for Commission action is 120 days after the later of either when the application is filed, when notice was mailed, or when notice is published. One hundred and twenty days after September 28, 2018 is Saturday, January 26, 2019. Since the Commission is closed, the period runs until the end of the next day on which the Commission is open for business, Monday, January 28, 2019.
