**UNDINE TEXAS ENVIRONMENTAL, LLC'S**  
**REQUEST FOR EXTENSION**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW Undine Texas Environmental, LLC ("Undine") and files this Request for Extension.

On January 25, 2019, Order No. 8 was entered establishing July 24, 2019 as the deadline for Applicants to complete the transaction. For the reasons set forth herein, Undine hereby requests a sixty (60) day extension, to September 22, 2019, to complete the transaction.

**I.**

**DISCUSSION**

The Commission rules provide that the 180-day deadline to complete the transaction may be extended for good cause shown. 16 Tex. Admin. Code § 24.109(o). Undine and the seller, Bolivar Utility Services, LLC, have been working diligently since the entry of Order No. 8 to close the transaction within the 180-day timeframe. Despite those efforts, the applicants recently identified one unanticipated impediment to closing (relating to the provision of title insurance). The applicants anticipate that issue will be addressed within the next thirty (30) days, allowing for a closing within the next forty-five (45) days. In order to protect against any other potential short-term delays, Undine seeks an extension of sixty (60) days. Undine does not seek this extension for purposes of delay.


**CONCLUSION**
