UNDINE TEXAS ENVIRONMENTAL, LLC'S REQUEST FOR EXTENSION

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW Undine Texas Environmental, LLC ("Undine") and files this Request for Extension.

On July 22, 2019, Order No. 9 was entered establishing September 22, 2019 as the deadline for Applicants to complete the transaction. For the reasons set forth herein, Undine hereby requests a two week extension, to October 6, 2019, to complete the transaction.

I.

DISCUSSION

The Commission rules provide that the 180-day deadline to complete the transaction may be extended for good cause shown. 16 Tex. Admin. Code § 24.109(o). Undine and the seller, Bolivar Utility Services, LLC, have continued to work diligently since the entry of Order No. 9 to close the transaction by September 22, 2019. The Parties were able to complete the title review that had slowed the transaction. However, that title review identified issues requiring resolution before the necessary title commitment could be issued. Undine and Seller have determined they require an additional week to work out the final details to get the title commitment in its final form. They have scheduled the closing for the transaction for September 25, 2019. Undine hereby requests a two week extension to October 6, 2019, to address any unanticipated complications

(which the Parties do not anticipate), having scheduled a preliminary closing for September 24, 2019. The undersigned represents that Undine does not seek this extension for purposes of delay.

II.

CONCLUSION

Undine respectfully requests that the Request for Extension to October 6, 2019 be granted. The undersigned has consulted with counsel for Commission Staff, who has indicated they do not oppose this request.
