## ORDER NO. 3 ADDRESSING SUFFICIENCY OF APPLICATION AND NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's recommendation regarding administrative completeness of the application and proposed notice of the City of Los Fresnos and East Rio Hondo Water Supply Corporation (collectively, applicants). Commission Staff recommended that the administrative law judge (ALJ) find that the application is administratively complete. Commission Staff also recommended that the administrative law judge require applicants to 1) provide correct notice of the application, with current rates, and the effective dates those rates were instituted, to all affected customers in the requested area; 2) include a copy of an accurate map delineating the proposed area with each individual notice; and 3) within 30 days of the date of the notice, file in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, as well as the date that the notice provided. Commission Staff also proposed a procedural schedule for continued processing of this application.

The ALJ finds that the application is administratively complete and directs the applicants to provide notice of the application as described in Commission Staff's recommendation using the included forms.

The proposed procedural schedule is adopted as follows:
