Be advised that North Fort Bend Water Authority's (Authority) Groundwater Reduction Plan Fee has changed.

On December 21, 2017, the Authority's Board of Directors approved an Amended Rate Order that changed the Groundwater Reduction Plan (GRP) Fee effective January 1, 2018. The preexisting GRP Fee was \$3.05/1,000 gallons. The amount of the pass-through in the tariff did not include any adjustments for line losses.

The Groundwater Reduction Plan Fee to be charged is \$3.35/1,000 gallons (\$3.68/1,000 gallons when adjusted for line loss).

This change by the Authority requires Undine to provide you NOTICE under 16 Texas Administrative Code § 24.21(b)(2)(E)(ii) of a TARIFF RATE REVISION as follows:

# North Fort Bend Water Authority Groundwater Reduction Plan Fee

(723 Utility/Riverside Ranch Subdivision only).....\$3.68

(Adjusted for line loss)

This tariff change is being implemented in accordance with the minor tariff changes allowed by 16 Texas Administrative Code § 24.21. The cost to you as a result of this change will not exceed the costs charged to your utility.
