**AQUA'S REQUEST FOR EXTENSION**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Aqua Texas, Inc., Aqua Utilities, Inc., and Aqua Development, Inc. d/b/a Aqua Texas (Aqua) and files this Request for Extension. In support thereof, Aqua would show the following.

On March 26, 2018, Aqua filed an application for approval to implement a new Federal Tax Change Credit Rider (Application). Staff filed its Final Recommendation on July 6, 2018. On August 2, 2018, the Commission issued a Notice granting an extension for parties to file an agreed proposed order because Aqua needed additional time to review the tariff documents attached to Staff's Final Recommendation. This pleading is therefore timely filed.


Since July 6, 2018, the parties have been reviewing and working on the tariff documents attached to Staff's Final Recommendation and agreeing to certain changes to the same. Staff is currently preparing to file amended tariff documents based on those exchanges, but Staff will not be able to prepare and file the new tariff documents prior to the current deadline to file an agreed proposed order of August 13, 2018.

Therefore, Aqua respectfully requests that the deadline for the parties to file an agreed proposed order be extended to Monday, August 20, 2018. Aqua has conferred with Commission Staff about this request and Commission Staff does not oppose the requested extension.

**PRAYER**

Aqua Texas, Inc., Aqua Utilities, Inc., and Aqua Development, Inc. d/b/a Aqua Texas respectfully requests that the Honorable Administrative Law Judge extend the deadline for parties to file an agreed proposed order to Monday, August 20, 2018. Further, Aqua requests that the ALJ ultimately grant Commission approval for the Application.


