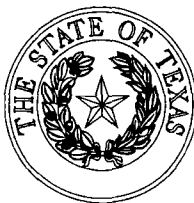

### **CORRECTIONS TO PROPOSED ORDER**

The Commission is currently scheduled to consider this docket at an open meeting to begin at 9:30 a.m. on Thursday, April 4, 2019, at the Commission's offices, 1701 North Congress Avenue, Austin, Texas. On March 27, 2019, the parties filed corrections to the Proposed Order filed on March 18, 2019.

The Commission declines to make the change to "FTCC rider" and will leave references as is. The following corrections are approved and made to the Proposed Order:

#### **I. Findings of Fact**

##### **Application**

6. On March 26, 2018, Aqua filed an application requesting approval of a proposed FTCC rider for each of the 2424 tariffs it has on file with the Commission.

##### **Evidentiary Record**

12. In a notice issued on October 11, 2018, the ALJ admitted the following evidence into the record: (a) Aqua's FTCC rider application filed on March 26, 2018; (b)



Commission Staff's recommendation on sufficiency of the application filed on April 25, 2018; (c) Notice Approving Interim Rate and Establishing Procedural Schedule filed on May 1, 2018; (d) Commission Staff's final recommendation and attachments filed on July 6, 2018; (e) Affidavit of notice to customers filed July 10, 2018; and (f) Commission Staff's tariffs filed on August 20, 2018 and supplemental corrected tariffs on November 1, 2018.

### **Interim Rates**

15. In a notice issued on May 1, 2018, the ALJ granted Aqua's request and approved the FTCC rider on an interim basis for each of the 242+ tariffs.

### **Tariffs**

21. On August 20, 2018, November 1, 2018, Commission Staff filed the proposed tariffs and filed supplemental corrected on November 1, 2018.

## **II. Conclusions of Law**

Conclusion of Law (COL) number 4 did not get numbered; therefore, new COL number 4 is added and 4 through 10 are renumbered accordingly as 5 through 11.

## **III. Ordering Paragraphs**

6. The Commission approves the tariffs filed by Commission Staff on August 20, 2018 and filed supplemental corrected tariffs on November 1, 2018.
7. Within ten days after the date of this Notice, Commission Staff must provide a clean copy of the tariffs approved in this Notice to central records to be marked Approved and filed in the Commission's tariff book.
