#### **COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Supplemental Recommendation in response to a Notice Approving Interim Rate and would show the following:

#### I. BACKGROUND

On April 2, 2018, J & S Water Company, LLC (J & S) filed an application to implement a pass-through rate change due to an increase in water use fees imposed on J & S by the North Harris County Regional Water Authority. J & S seeks to increase its pass-through rate to \$4.00 per 1,000 gallons effective April 1, 2018. On April 9, 2018, J & S filed supplemental information regarding its application. On April 30, 2018, Staff filed a recommendation that J & S be directed to re-notice its customers to cure notice deficiencies. On May 9, 2018, J & S filed a revised customer notice.

On May 11, 2018, a Notice Approving Interim Rate was issued, directing J & S to reissue corrected notice to its customers and establishing a deadline of June 13, 2018, for Staff to file a supplemental recommendation on the application. This pleading is therefore timely filed.

#### **II. RECOMMENDATION**

As detailed in the attached memorandum from Kathryn Eiland in the Commission's Water Utility Regulation Division, Staff has reviewed the application, notice, supplemental information, and revised notice and recommends that the requested pass-through rate be approved as calculated by J & S with a 15% line loss and that the attached tariff pages be issued to J & S.

Staff notes that the revised notice incorrectly states that the rate increase is \$1.24 per 1,000 gallons when the actual increase is \$0.59 per 1,000 gallons. Staff recommends that the notice be found sufficient despite this discrepancy because the notice overstates the amount of the increase and shows the correct previous and adjusted pass-through amounts, and because no ratepayer protests, comments, or intervention requests have been filed.

In addition, Staff recommends that J & S's request for a pass through true up adjustment clause be denied because J & S did not support the need for a true up adjustment clause and is only passing through one charge from one entity. Under 16 TAC 24.21(b)(2)(C)(v) and (b)(2)(D), a true up adjustment is designed for scenarios in which a utility passes through multiple costs from multiple entities under a combined pass-through clause.

#### **III. CONCLUSION**

For the reasons detailed above, Staff recommends that J & S's pass-through rate be approved, that J & S's request for a true up adjustment clause be denied, and that the attached tariff sheets be issued to J & S.

Through Rate Change

On April 2, 2018, J & S Water Company, LLC (J & S), Certificate of Convenience and Necessity (CCN) No. 12085 filed an application to implement a pass-through rate change pursuant to 16 Texas Administrative Code (TAC) § 24.21. The pass-through adjustment is for an increase in the water pumpage fee billed by North Harris County Regional Water Authority (NHCRWA) to \$3.40 per 1,000 gallons effective April 1, 2018. J & S also requested to add a pass-through true-up adjustment clause to its tariff per 16 TAC § 24.21.

On May 11, 2018, the Commission approved an interim pass-through rate of \$4.00 per 1,000 gallons and required J & S to reissue notice to customers with the correct approved NHCRWA pass-through rate from Tariff Control No. 47067. On May 9, 2018, J & S filed a copy of the revised notice to customers. Staff reviewed the application and new notice and has determined that both meet the requirements of 16 TAC § 24.21. Additionally, Staff notes that J & S did not provide the need for a true-up adjustment clause or the information needed to design a true-up adjustment clause, such as a basis for estimating future costs and historical documentation of under or over recovery of the charges for the past three years in its original application or supplemental filing. A true-up report is required by 16 TAC § 24.21(b)(2)(D) in association with a combined pass-through provision, which includes more than one pass-through provider and multiple costs. J & S has only one pass-through provider. Therefore, Staff recommends that the request for the true-up adjustment clause be denied. Also, 16 TAC § 24.21(b)(2)(E) provides that line loss will be considered on a case-by-case basis. Staff typically recommends that no more than 15% line loss be allowed in the calculation with no explanation. The line loss reported by the Applicant is 19% and no explanation has been provided. Therefore, Staff recommends that 15% line loss be used in the calculation of the pass-through adjustment.

Staff recommends that the Commission do the following:

- 1. Approve the requested pass-through rate of \$4.00 per 1,000 gallons as requested; and
- 2. Provide J & S a copy of the attached tariff.
