### COMMISSION STAFF'S RECOMMENDATION ON FINAL DISPOSITION

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Commission Staff's Recommendation on Final Disposition and would show the following:

### I. BACKGROUND

On April 10, 2018, Stanley Lake Municipal Utility District (Stanley Lake) filed an application to amend Certificates of Convenience and Necessity (CCN) Nos. 11222 (water) and 20483 (sewer) and to decertify a portion of T&W Water Service's (T&W) CCN No. 12892 and SC Utilities' (SC) CCN No. 20586 service area in Montgomery County. The requested area consists of approximately 739 total acres including nine (9) acres decertified from T&W Water Service and nine (9) acres decertified from SC Utilities, and six (6) current customers.

On August 3, 2018, the administrative law judge (ALJ) issued Order No. 4, finding notice sufficient, and requiring Staff to file a final recommendation on the application by September 25, 2018. Since not all of the consent forms were filed, Staff requested an extension to the filing deadlines. The ALJ granted this request in Order No. 5 on September 21, 2018, and set a new deadline for Staff to file a final recommendation on the application by November 1, 2018. Therefore, this pleading is timely field.

### II. RECOMMENDATION ON FINAL DISPOSITION

Staff has reviewed Stanley Lake's application, and as detailed in the memorandum of Debbie Reyes of the Commission's Water Utility Regulation Division (Attachment A), Staff recommends that the application be approved. In accordance with this recommendation, the

corresponding maps (Attachment B), and certificates (Attachment C), that Stanley Lake, T&W and SC consented to in their September 20, 2018 and October 2, 2018 filings are attached. On or before November 8, 2018, the parties will jointly file proposed findings of fact and conclusions of law.

### III. CONCLUSION

Staff respectfully requests that the ALJ issue an order consistent with the above recommendation.

On April 10, 2018, Stanley Lake Municipal Utility District (Applicant), filed with the Public Utility Commission of Texas (Commission) an application to amend Certificate of Convenience and Necessity (CCN) Nos. 11222 (water) and 20483 (sewer) and to decertify a portion of T&W Water Service's CCN No. 12892 and SC Utilities' CCN No. 20586 in Montgomery County, Texas pursuant to Texas Water Code Ann. (TWC), §§ 13.242 - 13.250 and 16 Tex. Admin Code (TAC) §§ 24.225-.237 (formerly §§ 24.101 - 24.107).

### **Background**

The Applicant is seeking to amend its water and sewer CCN boundaries to align with its district boundaries. The requested area consists of approximately 906 acres, which includes approximately 149 acres of area that was previously certificated to the Applicant as facility lines, the addition of approximately 739 acres of uncertificated area and the addition of approximately 9 acres to be decertified from T&W Water Service, and the addition of approximately 9 acres to be decertified from SC Utilities.

### **Notice**

The deadline for intervention was July 6, 2018. No requests for hearing or intervention were received by the Commission.

### Criteria Considered

TWC § 13.246(c) requires the Commission to consider nine criteria when granting or amending a CCN. Therefore, the following criteria were considered:

### TWC §13.246(c)(1) requires the commission to consider the adequacy of service currently provided to the requested area.

Currently, the Applicant has adequate water and sewer services for its customers within the district. The update of its CCN boundary to align with the district boundary, will not alter the adequacy of service provided to the requested area.

## TWC §13.246(c)(2) requires the commission to consider the need for service in the requested area.

The requested area encompasses the Applicant's district boundary. The Applicant is requesting to amend its CCN boundaries to align with its district boundaries.

## TWC §13.246(c)(3) requires the commission to consider the effect of granting an amendment on the recipient and on any other retail public utility servicing the proximate area.

The Applicant has provided signed agreements with the existing CCN holders, SC Utilities, and T&W Water Service Company, for the areas to be decertified that are located in the requested area.

## TWC §13.246(c)(4) requires the commission to consider the ability of the applicant to provide adequate service.

The Applicant is a municipal utility district and is obligated to provide adequate water supply and sewer treatment within its district boundaries. The requested area will be served by its existing public water facilities, Stanley Lake MUD (PWS ID No. TX1700097), which is that is registered with the Texas Commission on Environmental Quality (TCEQ) and in compliance with TCEQ requirements.

## TWC §13.246(c)(5) requires the commission to consider the feasibility of obtaining service from an adjacent retail public utility.

The consideration of an adjacent retail utility to serve the area is not applicable, since there was an agreement between the Applicant and SC Utilities, and T&W Water Service Company to update its CCN boundaries.

TWC § 13.246(c)(6) requires the commission to consider the financial ability of the applicant to pay for facilities necessary to provide continuous and adequate service and the financial stability of the applicant. 16 TAC § 24.11 establishes criteria to demonstrate that an owner or operator of a retail public utility has the financial resources to operate and manage the utility and to provide continuous and adequate service to the current and proposed utility service area. 16 TAC § 24.11(e) lists the financial tests.

The Applicant meets one of the five leverage tests. The Applicant has an A credit rating from Standard and Poor's, which is above the minimum of BBB-, and meets the credit rating leverage test of investment grade.

The Applicant meets the operations test. The owner or operator must demonstrate sufficient cash is available to cover any projected operations and maintenance shortages in the first five years of operations. The Applicant has not submitted any projections in its application; however, based on the 2017 Stanley Lake MUD Annual Audit Report, specifically the Water Utility Fund Statement of Revenues, Expenses, and Changes in Fund Net Position, the District had \$95,928 in operating income. Thus, there are no shortages to cover.

## TWC §§ 13.246(7) and (9) require the commission to consider the environmental integrity and the effect on the land to be included in the certificate.

The environmental integrity and the effect on the land will be minimally impacted from the Applicant providing water and sewer services to the requested area as it develops.

## TWC § 13.246(8) requires the commission to consider the probable improvement in service or lowering of cost to consumers.

Services to the requested area will be comparable to the services currently provided to the existing customers by the Applicant.

The Applicant meets all of the statutory requirements of TWC Chapter 13 and the Commission's Chapter 24 rules and regulations, and is capable of providing continuous and adequate service, approving this application to amend the CCN is necessary for the service, accommodation, convenience and safety of the public.


The Applicant, SC Utilities, and T&W Water Service Company consented to the attached map and certificates on September 20, 2018, respectively.

Based on the above information, Staff recommends the Commission approve the application, issue an order and provide the attached maps, and certificates to the Stanley Lake MUD, T&W Water Service and SC Utilities. Staff further recommends that the Applicant file certified copies of the CCN map along with a written description of the CCN service area in the county clerk's office pursuant to TWC §§ 13.257 (r)-(s).


### Stanley Lake MUD Water CCN No. 11222 PUC Docket No. 48250 Amended CCN No. 11222 and


